

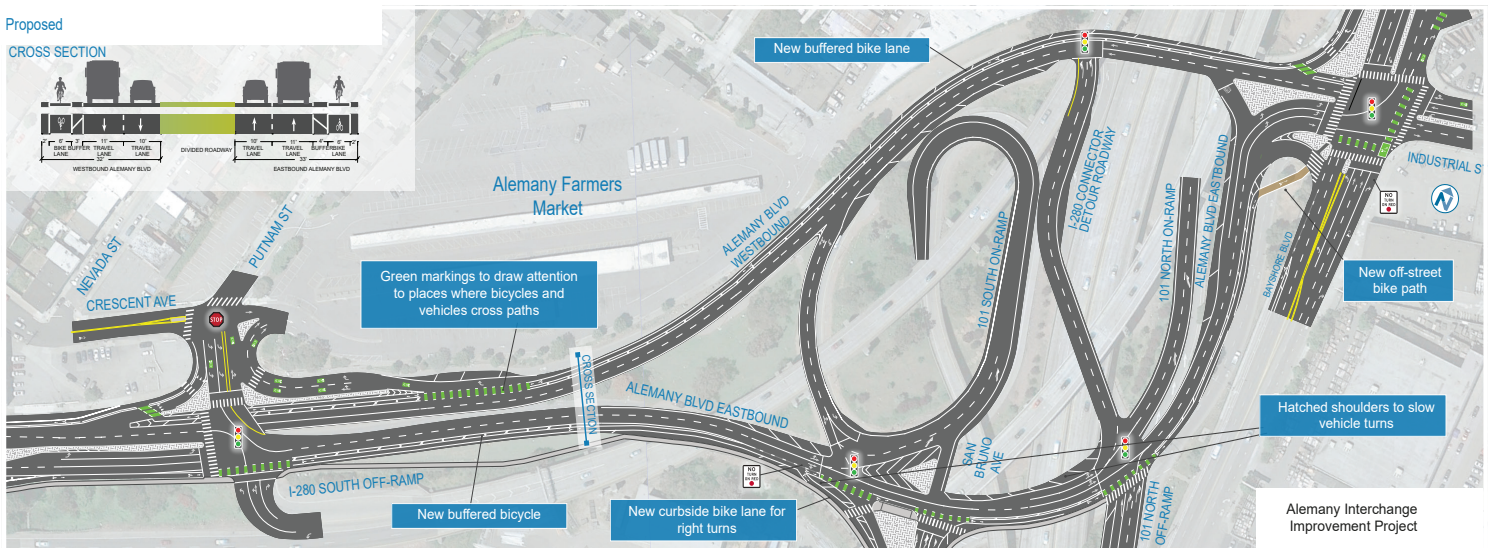

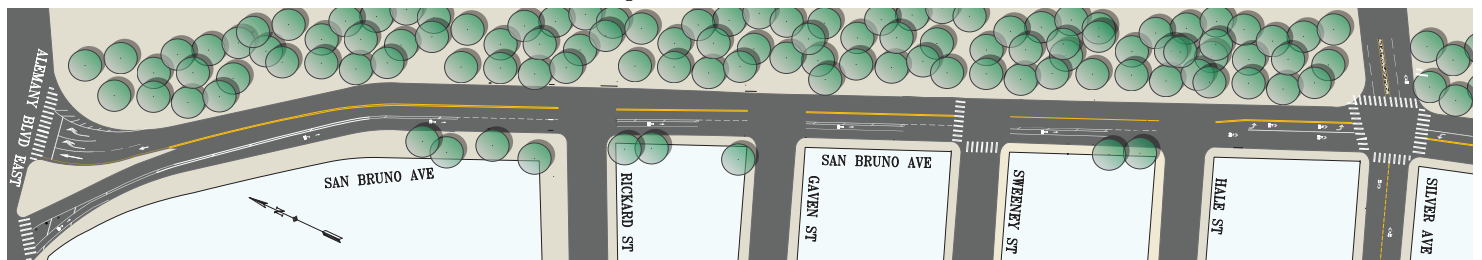
Alemany Interchange Improvements Project Legislation Update

Alemany Interchange Proposed Improvements

The Alemany Interchange Improvements Project proposes striping changes for safer cycling and walking through the “Alemany Maze” including new buffered bike lanes, flexible delineator posts to separate the bikeways from vehicles, hatched shoulders and narrowed travel lanes to reduce speeding, and high visibility crosswalks. The project also proposes a buffered bike lane southbound on San Bruno Avenue from Alemany Boulevard to Silver Avenue. SFMTA staff anticipate no changes to parking from these improvements. The San Francisco Municipal Transportation Agency Board of Directors will consider this proposal at their August 21, 2018, meeting

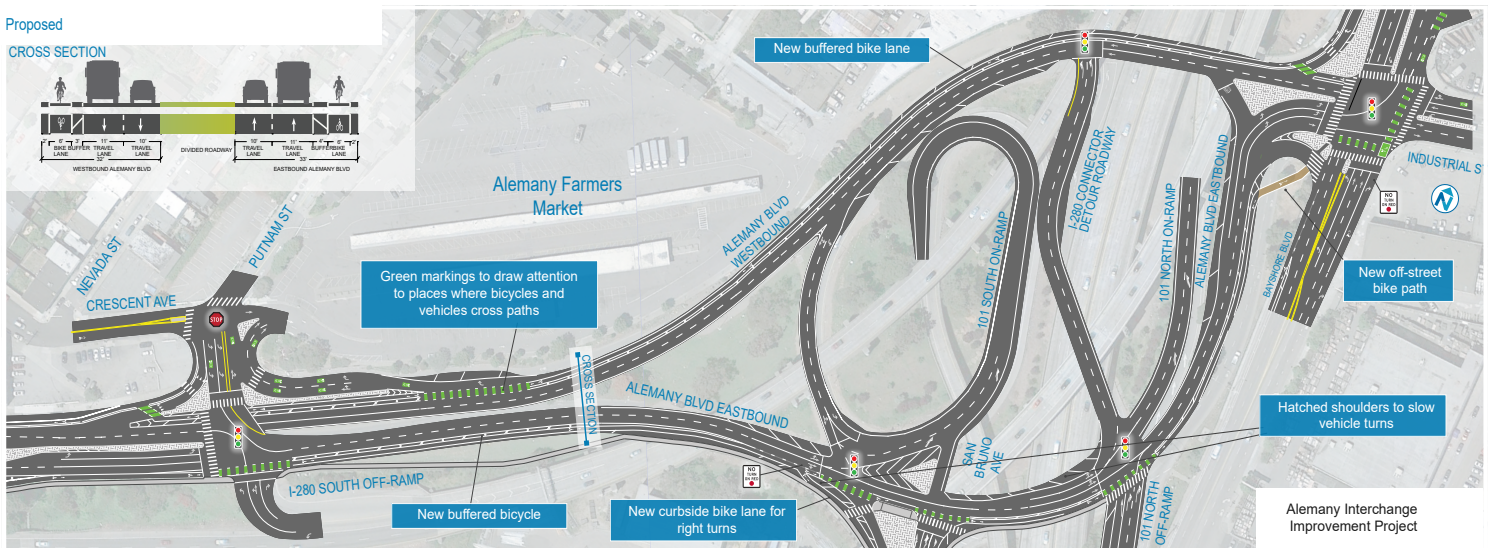

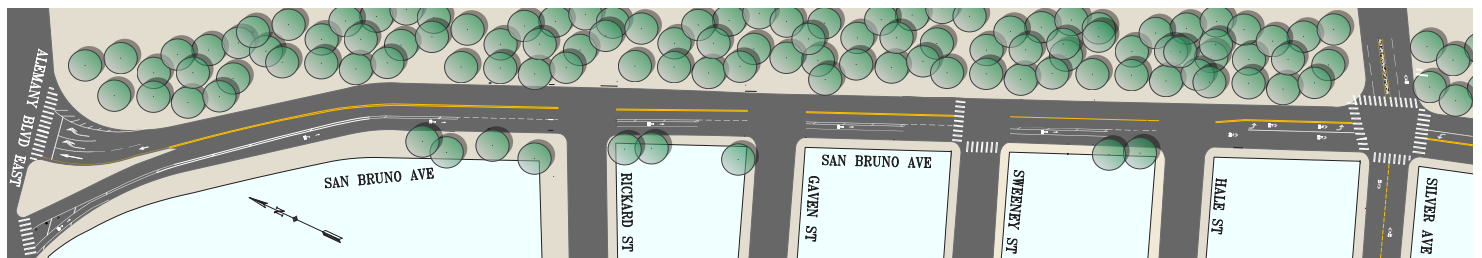
ALEMANY 交匯處改善項目 - 立法信息

Alemany 交匯處改善項目建議對更安全的騎單車和步行進行條帶化改變 Alemany 街的迷宮“Alemany Maze”包括新的緩沖的單車道，靈活的輪廓標記柱，用於分隔單車道車輛，和狹窄的行車道，以減少超速行駛和高可見性人行橫道。該項目還建議在 San Bruno 街南行從 Alemany 大道到 Silver 街的緩沖單車道。三藩市交通局預計這些改進不會改變停車位。三藩市交通局董事會將在2018年8月21日（星期二）的會議上審議該提案。
