1 California Temporary Emergency Transit Lanes

Evaluation results are showing that transit lanes are improving travel times for 1 California buses, with minimal traffic impacts to the California Street corridor. In response to stakeholder feedback and evaluation findings, we are recommending maintaining transit lanes with some changes to locations and hours.



Between Presidio Avenue and Larkin Street, transit lanes would replace the curbside travel lanes on segments of California, Sacramento and Clay streets. Lanes would be in effect at all times. All on-street parking would be retained.

Between Larkin and Montgomery streets, transit lanes would introduce new parking restrictions in the curbside lane on segments of Sacramento and Clay streets, including: SFMTA Board of Directors Meeting Tuesday, January 18, 2022 1:00 p.m.

SFMTA

- Sacramento Street between Larkin and Stockton streets: Existing afternoon transit lane hours would be expanded to 3-7 p.m., decreasing the available hours of approximately 96 parking and loading spaces.
- Sacramento Street between Stockton and Kearny streets: The existing transit lane hours would be expanded to be 7-9 a.m. and 3-7 p.m., decreasing the available hours of approximately 24 parking and loading spaces.
- Sacramento Street between Montgomery and Stockton: The existing 4-6 p.m. PM towaway lane on the south side of the street would be rescinded, increasing the available hours of approximately 34 parking and loading spaces.
- Clay Street between Larkin and Powell streets: A new transit lane would be installed from 7-10 a.m. and 3-7 p.m., decreasing the available hours of approximately 70 parking and loading spaces.
- Clay Street between Stockton Street and Grant Avenue: The existing transit lane hours would be expanded to be 7-9 a.m. and 3-6 p.m., decreasing the available hours of approximately 12 parking and loading spaces.

Between Leidesdorff and Front streets, the existing transit lane on Sacramento Street that is in effect from 7 a.m.-7 p.m. would become a full-time transit lane, removing 28 spaces of part-time parking.
