



PUBLIC HEARING

FOR PROPOSED PARKING & TRAFFIC CHANGES

Pursuant to SFMTA Order No. 5440 adopted July 10, 2015,
the San Francisco Municipal Transportation Agency will hold a public hearing
to solicit public input on the following proposed changes. The hearing will be held as follows:

Date/Time: Friday, July 24, 2015, at 10:00 am
Location: Room 416 (Hearing Room 4), City Hall, San Francisco
(located on Van Ness Avenue between McAllister and Grove Streets)

ESTABLISH – PASSENGER LOADING ZONE, 7AM – 10PM, DAILY

50 Riza Street, north side, from 128 feet to 158 feet west of Lapu Lapu Street (30-foot zone)

ESTABLISH – YELLOW LOADING ZONE, 7AM-6 PM, MONDAY THROUGH FRIDAY

“52” Riza Street, north side, from 158 feet to 178 feet west of Lapu Lapu Street (30-foot zone)

EXTEND – SCHOOL BUS LOADING ZONE, 7 AM – 4 PM, SCHOOL DAYS

“281” Oneida Avenue, south side, from 95 feet to 125 feet east of Delano Avenue (extends existing school bus loading zone by an additional 30-feet)

ESTABLISH – PART-TIME PASSENGER LOADING ZONE, 8 AM – 9 AM, 1:30 – 3 PM, SCHOOL DAYS

423 Burrows Street, south side, from Goettingen Street to 100 feet westerly (100-foot zone)

ESTABLISH – PART-TIME PASSENGER LOADING ZONE, 7:30 AM – 9:30 AM, 3 – 6 PM, SCHOOL DAYS

“701” Alabama Street, east side, from 11.5 feet to 54.5 feet south of 19th Street (43-foot zone)

ESTABLISH – SHORT-TERM GREEN PARKING METER, 30-MINUTE LIMIT

“1534” Howard Street, north side, from 60 feet to 80 feet east of Lafayette Street, at parking meter stall #1522 (20-foot zone)

ESTABLISH – BLUE ZONE

1800 Taraval Street, north side, from 3 feet to 21 feet west of 28th Avenue, replacing parking meter stall #1802 (18-foot zone)

ESTABLISH – METERED YELLOW LOADING ZONE, 7 AM-6 PM, MONDAY THROUGH SATURDAY

1532 Howard Street, north side, from 80 feet to 102 feet east of Lafayette Street, at parking meter stall #1520 (22-foot zone)

EXTEND – PART-TIME PASSENGER LOADING ZONE, 8 AM – 9 AM, 2 PM – 3 PM, SCHOOL DAYS

34th Avenue, west side, from 140 feet to 194 feet and from 316 feet to 340 feet north of Quintara Street (extends the existing passenger loading zone by 54 feet on the north side and 24 feet on the south side to create a zone totaling 200 feet in length)

ESTABLISH – PART-TIME PASSENGER LOADING ZONE, 7AM - 9 AM, 1:30 PM - 4 PM, SCHOOL DAYS

2201 Broadway, south side, from 15 feet to 87 feet west of Webster Street (72-foot zone)
