2. **ESTABLISH – SHORT TERM METERED PARKING (15-MINUTE LIMIT), 9AM TO 6PM, MONDAY THROUGH SATURDAY**
505 Brannan Street, south side, from 42 feet to 122 feet west of 4th Street, at metered parking stall #507, #509, #511 and #513(80-foot zone)
