3. Announcement of prohibition of sound producing devices during the meeting

Board Secretary Silva announced that ringing and the use of cell phones and similar soundproducing electronic devices were prohibited at the meeting.

6. Introduction of New or Unfinished Business by Board Members

Chair Eaken reflected on the recent Board Workshop on the topic of building trust in government and communities.

PUBLIC COMMENT:

Jim Haas expressed concern about the costs of projects and repaving, urging the SFMTA to do better.



Jaime Viloria shared that the SFMTA needs to engage with riders and be more consistent, building relationships with riders to show a culture of care.

Aleta Dupree reflected on how the SFMTA includes those that are different and asked the SFMTA to promote a culture of welcome.

Director Tumlin shared several legislative updates including on speed safety cameras and addressing the fiscal cliff, updates on the Muni Rider Survey results, the Active Communities Plan effort, the Battery Sansome Quick Build Project ribbon cutting, Slow Streets signage, Better Market Street, scooters, Capp Street barricades, and transit shelter maintenance.

Director Yekutiel asked for more information about the Better Market Street project, wanting to understand budget allocation.

Director Hinze requested information about bus/transit planning while the Better Market Street improvements are being made.

Chair Eaken requested that the Muni Rider Survey results be presented at a future meeting.

PUBLIC COMMENT:

Stacy Randecker expressed concern about fees and urged the SFMTA to present the requested network of Slow Streets corridors in the first quarter of the year.

Barry Taranto shared about Capp Street and expressed concern about roadwork and construction at Market and Montgomery Streets.

Aleta Dupree was unhappy to learn about Bird leaving the city and expressed concern about sidewalk riding enforcement.

Speaker commented on a disparity of what the Board says it wants versus what the SFMTA delivers and expressed concern about enforcement.



Leanne shared about being attacked while riding Muni and expressed concern about transit safety.

8. Citizens' Advisory Council Report

Michael Chen, Chair, Citizen's Advisory Council (CAC), presented the report.

Director Hinze requested the Board Secretary work with the CAC Secretary to remind the Board of CAC recommendations when the items are heard at the Board.

PUBLIC COMMENT:

Francisco DaCosta commented that current CAC members do not have transportation experience.

Edward Mason shared about a recommendation made to the CAC regarding signage on SamTrans vehicles.

9. Public Comment

Members of the public may address the SFMTA Board of Directors on matters that are within the Board's jurisdiction and are not on today's calendar.

Kathy Richter urged the SFMTA to restore the 3 Jackson line.

D. Woordruff shared that many people do not have the mobility to walk up hills and that there were many seniors with access issues.

Barbara Bocci urged the SFMTA to restore the 3 Jackson line, sharing that walking from Baker to California Streets is steep and challenging.

Kelly Connelly shared about her small business and urged the Board to restore the 3 Jackson line.

John Paxton urged the Board to restore 3 Jackson line.

Daniela Kirshenbaum expressed concern about the 3 Jackson line and questioned if the neighborhood could be added to the list of equity neighborhoods.

Paul Wermer shared about the former 4 Sutter line and urged the Board to save the 3 Jackson line.



Stacy Randecker expressed concern regarding parking enforcement and commented in support of requiring residential parking permits for every resident.

Adrienne Leifer expressed concern regarding the K Ingleside line and potential changes related to the L Taraval line.

Jaime Viloria expressed support for restoring the 3 Jackson line and was interested in understanding ridership data by line.

Mick Del Rosario spoke in support of restoring the 3 Jackson line, sharing that the SFMTA should prioritize investments.

Emily Murase expressed support for the 3 Jackson line, sharing that it is a lifeline for seniors and that equitable access to public transit is needed.

Barry Taranto shared about a recent customer experience, commented on the 3 Jackson line, and expressed concern about enforcement for illegally parked cars.

Speaker expressed concern about the one-way traffic lanes near 4th Street and the Central Subway station, sharing that drivers drive the wrong way.

Catherine Sweeney expressed concern regarding the re-routed 48 Quintara line on Tennessee Street, sharing that there was no community engagement about the change.

California Environmental Quality Act (CEQA) Appeal Rights under S.F. Admin. Code Chapter 31: For identified Approval Actions, the Planning Department or the SFMTA has issued a CEQA exemption determination or negative declaration, which may be viewed online at the Planning Department's website. Following approval of the item by the SFMTA Board, the CEQA determination is subject to appeal within the time frame specified in S.F. Administrative Code Section 31.16 which is typically within 30 calendar days. For information on filing a CEQA appeal, contact the Clerk of the Board of Supervisors at City Hall, 1 Dr. Carlton B. Goodlett Place, Room 244, San Francisco, CA 94102, or call 415.554.5184. Under CEQA, in a later court challenge, a litigant may be limited to raising only those issues previously raised at a hearing on the project or submitted in writing to the City prior to or at such hearing, or as part of the appeal hearing process on the CEQA decision.

<u>Board of Supervisors review of certain SFMTA Decisions:</u> Certain parking and traffic modifications as well as Private Transportation Programs that involve certain parking modifications can be reviewed by the Board of Supervisors. These decisions are subject to review within 30 calendar days after they are made by the SFMTA Board of Directors.
