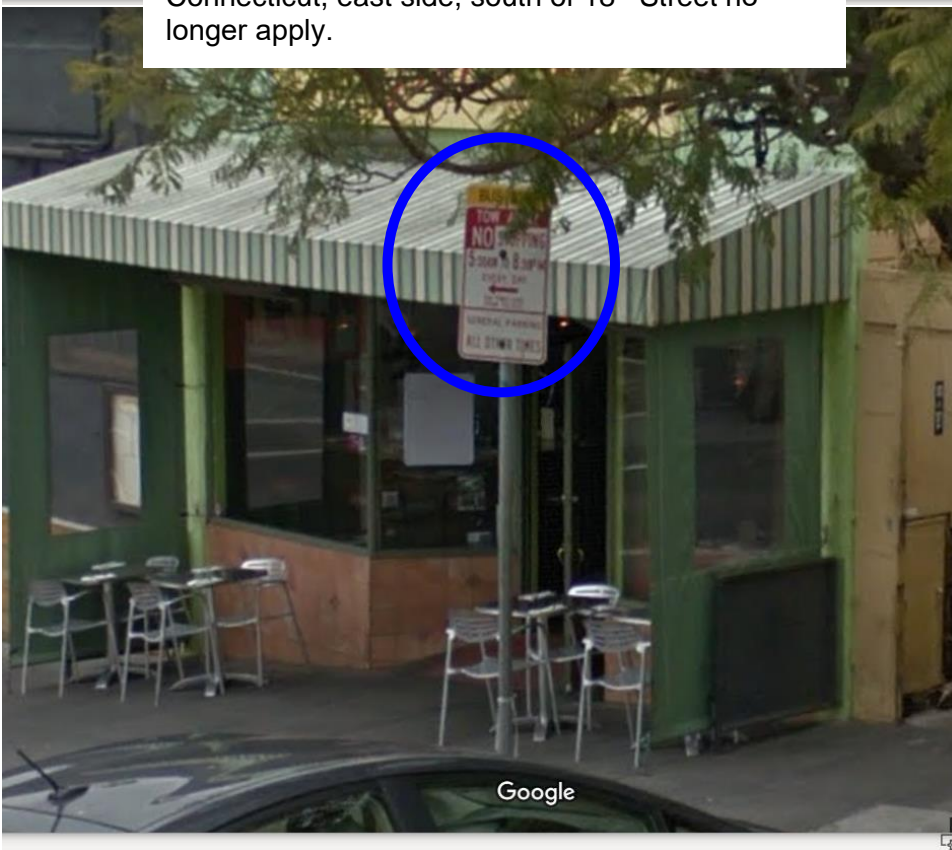
BACKGROUND INFORMATION / COMMENTS

- *Directive to enforce full time bus zone was signed on 1/22/2021. This legislation is a follow-up to the directive.
- *Work order to remove part time bus zone signs was sent on 2/8/2021.
- *Bus zone was previously used solely by Muni line 10 Townsend (currently suspended)
- *Today, bus zone is also used by Muni line 55 Dogpatch as a part of a reroute that took effect on 1/23/21
- *Bus zone now has different operating hours due to other added Muni service

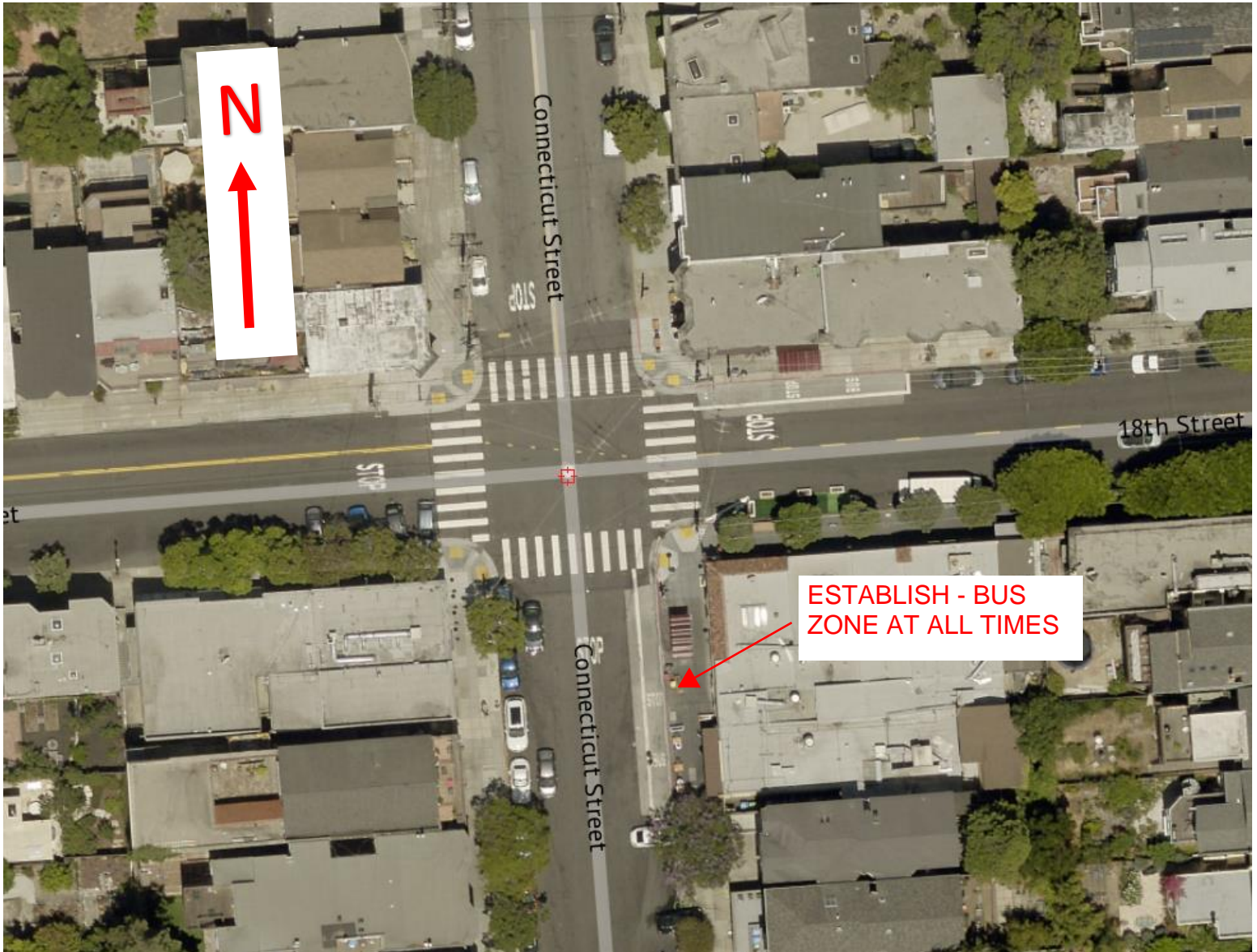

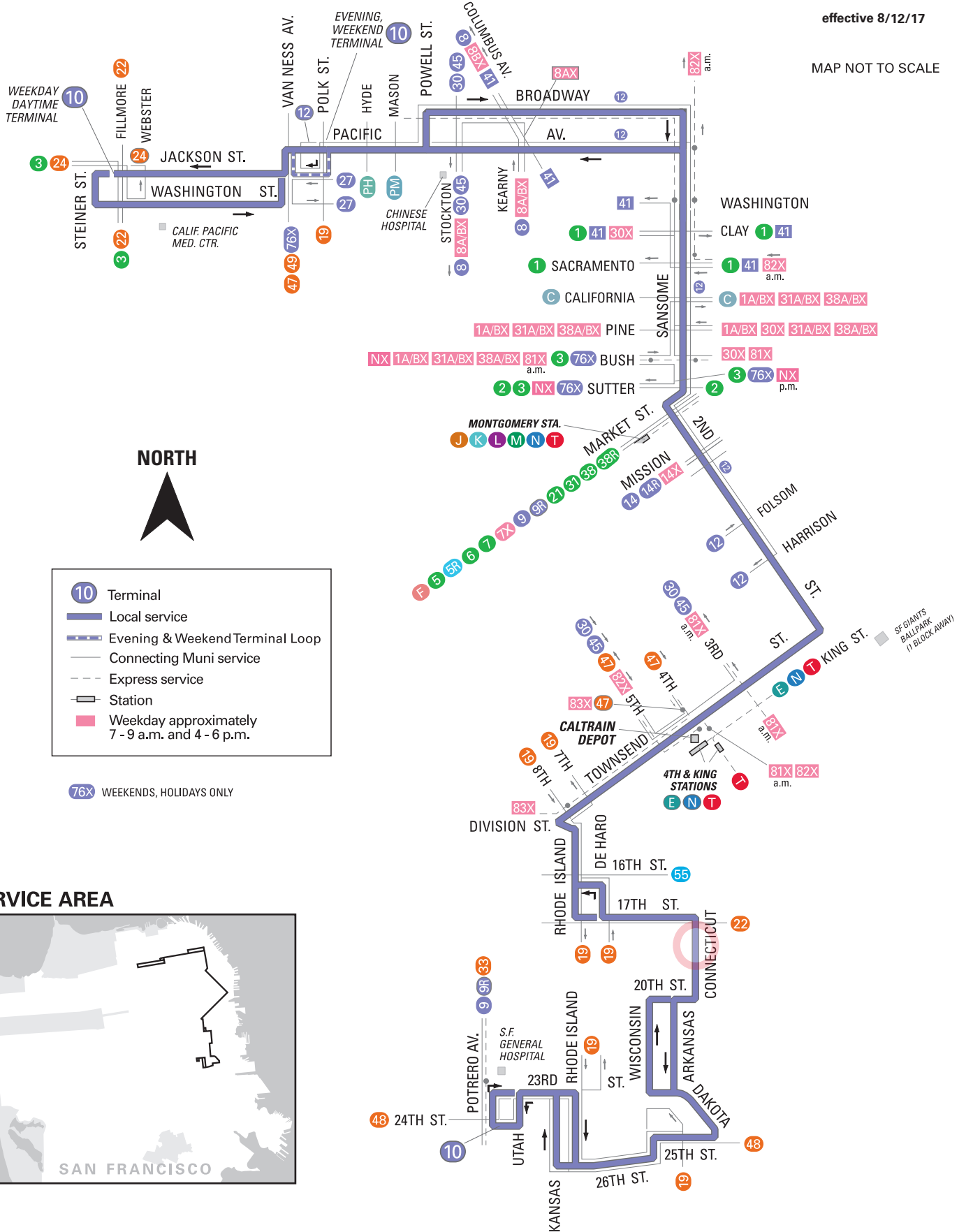

MAP NOT TO SCALE

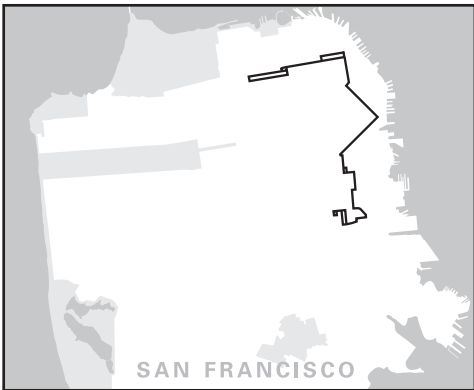

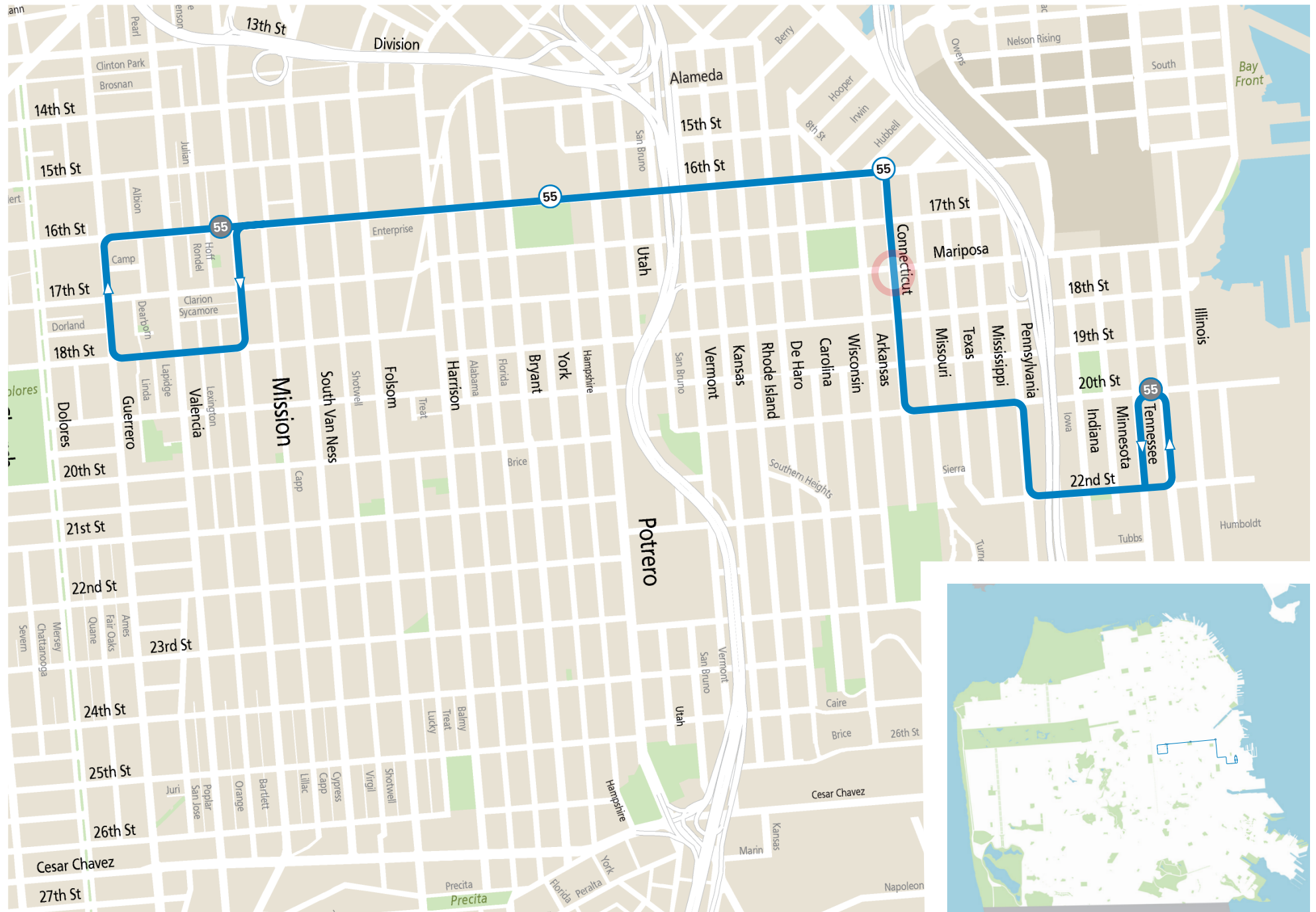
