144 Leavenworth Street, east side, from 102 feet to 142 feet south of Turk Street, at parking meter stalls #116-Q and #114-Q (40-foot zone)

REVOKE – YELLOW METERED LOADING ZONE, 7AM TO 1PM, MONDAY THROUGH FRIDAY

“498” Valencia Street, west side, from 12 feet to 52 feet north of 16th Street, at parking meter stalls #458 and #456 (60-foot zone)
