Accessible MUNI lines serving this location are: Muni Metro Lines J Church, K Ingleside, L Taraval, M Ocean View, N Judah and T Third at Van Ness and Civic Center Stations; F Market-Wharves; 47 Van Ness; 49 Mission-Van Ness; 6 Haight-Parnassus, 21 Hayes; 9 San Bruno; 7R Haight-Noriega Rapid; 9R San Bruno Rapid; and 7 Haight-Noriega.
