

**Appendix B
Calculation of Charges**

Contractor shall be reimbursed for the provision of Services as set forth in Appendix A of this Agreement according to the following rates:

1. Initial Test

The SFMTA will pay Contractor \$55 per driver per year for one annual new permit or permit renewal drug test, to be billed for the month in which the test is performed. Contractor shall otherwise remit monthly invoices for services provided in the previous month as set forth in the Agreement.

2. Miscellaneous Clinic-based Services

For other intermittent, as-needed services that are not included in the lump sum annual payment in paragraph 1 above, the City will pay the following rates per services:
