6. Public Comment:

Edward Mason provided a corporate commuter shuttle bus update. Two weeks ago there was a collision at 24th and Castro streets with a commuter shuttle bus. Buses still operate on 3-ton weight restricted streets and residential streets. The program has been going on for two years and it's a constant cat and mouse game. Facebook proposes to add more buses and there is no environmental impact report. There is pushback stating that the environmental impact report is incomplete. This is an issue that is going to be coming down the road.

Edward Mason stated that Delivery trucks are an impediment to the red carpet lanes. San Jose transit mall uses London Planetree in its landscaping. It's a mess when the leaves fall. East San Jose BRT was a total disaster. VTA has a lot of bad press. The contractor defaulted on the project. Businesses suffered financially because of the construction. He said that the SFMTA should look to that situation as a lesson learned so as not to make the same mistakes.

PUBLIC COMMENT:

Edward Mason inquired if San Bruno Ave leads into farmers market and would that preclude having a commuter shuttle bus hub. If the SFMTA were to make that area a hub, they would be looking at 100 buses an hour going in there.
