ESTABLISH – WHITE ZONE, PASSENGER LOADING, AT ALL TIMES

1 Jones Street, west side, from 22 feet to 142 feet north of McAllister Street, replacing metered stalls #3, #5, #7, #9, #11, #15 (120-foot zone)

-No opposition received, forwarded for implementation by directive 5992.

ESTABLISH – WHITE ZONE, **ACCESSIBLE PASSENGER LOADING, AT ALL TIMES**

75 Arkansas Street, east side, from 133 feet to 193 feet north of 17th Street (60-foot zone)

-No opposition received, forwarded for implementation by directive 5992 with minor changes.

ESTABLISH – PASSENGER LOADING, 5PM TO 2AM, MONDAY THROUGH SATURDAY

395 Hayes Street, south side, from 18 feet to 38 feet east of Gough Street, at metered stall #339 (20-foot zone)
