**Avoid unnecessary conversation as Operator safety requires 6 feet distance**

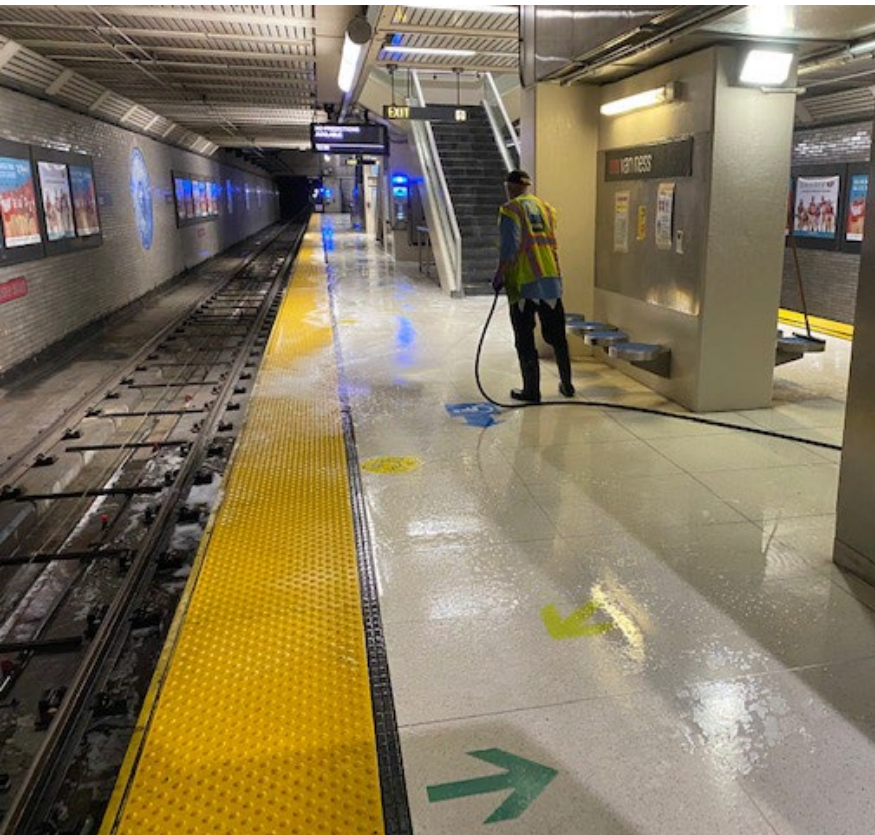
