BACKGROUND INFORMATION / COMMENTS  This project will consolidate pedestrian crossings of Turk Blvd at Kittredge Terrace and Roselyn Terrace, adjacent to the University of San Francisco campus. At Kittredge Terrace, the project will close the existing west side crosswalk, which is oriented at an extreme skew and serves no unique destinations to the east leg. At Roselyn Terrace, the project will close the existing east side crosswalk which serves no unique destinations to the west leg and enhance the west side crosswalk with a Rectangular Rapid Flashing Beacon (RRFB) and associated signage.										
Turk Blvd has Class II bikeways. Speed I	imit 30mph.									
Within the past five years, there was one collision within the project area, between a vehicle and a pedestrian in the crosswalk at Roselyn Terrace.										
31 Balboa Muni Route serves Turk Blvd. There is a concurrent project to re-locate the existing north side bus stop at Roselyn Terrace to the far side of the Roselyn Terrace crosswalk that will be enhanced with an RRFB.





#### Meeting notes:

- USF/UTA reviewed and confirmed general support for SFMTA draft proposals including:
  - "Key connections" improvement concepts at the Chabot and Tam Terrace intersections with Golden Gate Ave (USF-UTA funded)
  - Traffic calming and back-in angled parking on Golden Gate Ave (USF-UTA funded)
  - Turk/Roslyn flashing beacon upgrade and bus stop relocation (west leg) and related crosswalk closure, east leg (SFMTA funded)
  - Golden Gate Ave Slow Street treatments including markings/wayfinding devices between Parker and Masonic, and potential eastbound traffic diversion on the east side of Masonic (SFMTA-funded)
- Discussion items / comments
  - Potential crosswalk closure (west leg) of Turk/Kitteridge
    - Group voiced general support for crosswalk removal if it doesn't unduly affect USF occupancy permit approval timeline
      - USF just extended 3-month temporary approval, need to figure out schedule and level of effort for curb ramp changes
    - Potential left-turn restrictions / "right out only" treatments need further study and input from neighbors
  - Golden Gate / Tam Terrace
    - Group voiced support for potential STOP sign here with or without other traffic calming on Golden Gate Ave
  - Golden Gate/Roslyn load zone and east leg unmarked crosswalk
    - No need to add new crosswalk here (would affect eastbound load zone), but there should be a crosswalk nearby such as proposed at Tam Terrace (lots of midblock pedestrian activity here)

- Potential median islands with key connection improvements
  - Careful not to create undue blockage if there is double-parking and people need to drive/turn from side streets – painted islands today allow for flexibility
- Parker Ave
  - Comment of fast turning vehicles to/from Parker, request to consider traffic circle and/or other treatments
  - Agree to revisit potential improvements here after city develops cost estimates for existing scope of work
- Funding SFMTA seeking to modify the USF-UTA project disbursement schedule to fund environmental/approvals phase, allow for additional 'near-term' implementation

#### **Next steps**

- SFMTA to meet with Public Works re: completion of survey and sidewalk/curb ramp design
  - UPDATE: Met with Public Works accessibility group later in day, will be coordinating on preliminary construction estimate and proposed fee for detailed design phase
  - Raised crosswalk not recommended for new Tam Terrace crosswalk (SFMTA to pursue STOP control and/or traffic calming as noted elsewhere)
- SFMTA-USF coordination re: curb ramps and street permit(s)
  - UPDATE: SFMTA internal meeting set with Norman Wong for 12/15
- SFMTA to keep group updated of next steps for Golden Gate Slow Street including outreach/engagement opportunities in early 2022
- Casey to coordinate with Liz on developing fund request details and scheduling future group meeting prior to any public hearings/outreach.

All - See below email thread and attached SFPW DAC comments. Looks like they concur with your crosswalk closure comments and they noted the requirement to install the ped barricades. The other attached email contains BUF comments and they only have one minor comment. Thus, please confirm that:

- 1. SFMTA (not UCSF) will be the responsible party to install the ped barricades on the south side of the Turk (at Kittridge and Roselyn Terrace)
- 2. LS or TE staff to conduct MTAB legislation for the requested crosswalk closures and to prepare directive to approve closure while it goes through the permanent legislation process.
- 3. LS or TE staff to prepare WO for removal of crosswalk striping, installation of ped barricades per comment #1, and to update official STRs

I will keep you updated on when construction starts and Item #3 may need to be implemented by the time the UCSF starts the sidewalk work by Roselyn Terrace since they will remove the curb ramp on the north side of Turk.






