## ***PUBLIC HEARING RESULTS***

#### **3PM TO 8PM, MONDAY THROUGH FRIDAY AND 9AM TO NOON, SATURDAY**

44 Page Street, north side, from 157 feet to 223 feet west of Franklin Street, at metered stall no. 20, 22 and 24 (66-foot zone)
