The SFMTA has reviewed your permit application for participation in the Commuter Shuttle Program from July 1, 2021, through June 30, 2022. The SFMTA has approved your permit application. This letter and its attachments constitute the 2021-2022 Commuter Shuttle Permit No.11, authorizing MV Transportation Mission Bay. (Permittee) to participate in SFMTA's Commuter Shuttle Program.

Under the terms of this permit, Permittee is authorized to load and unload passengers at Designated Network zones in accordance with the Permit Terms and Conditions for Permit Year 2021-2022 attached as Attachment A and using only those vehicles bearing the license plates on the list of Authorized Vehicles maintained on Permittee's Salesforce profile, which is incorporated by reference.

The Designated Network consists of zones legislated by the SFMTA for use by permitted commuter shuttle buses. The Designated Network zones are available at <a href="https://www.sfmta.com/commutershuttles">www.sfmta.com/commutershuttles</a>.
