Director Heminger requested that when staff prepares the flag stop item for the Board, they include information explaining what it would take to speed up the work and reduce time in half.



Director Yekutiel thanked Superintendent Young Laolagi and staff a recent Light Rail - Track Maintenance site visit.

Vice Chair Eaken and Director Hinze were supportive of a policy discussion regarding flag stops.

Director Tumlin shared about upcoming Central Subway events, Quick Build Project updates, announced the new Chief Financial Officer (CFO), thanked Acting CFO Jonathan Rewers, shared about an upcoming safety All-Staff presentation, changes to cable car service, gearing up for 75th anniversary of Friedel Klussmann Event on October 26, and Proposition L in the upcoming election.

Cajina requested presentation on safety.

Eaken requested a legislative wrap up of the year.

PUBLIC COMMENT:

Patricia Vaughey expressed concern over security at the Pierce Street garage and bike racks in front of a Walgreens in her neighborhood.

Herbert Weiner asked about Central Subway service and expressed concern over Proposition L and transit safety.

Aleta Dupree commented on Proposition L and expressed concern over sideshows and safety.

David Pilpel encouraged voters to read the voter information pamphlet for Proposition L and questioned potential conflicts of interest related to Director Yekutiel and the Valencia Street Project.



Barry Taranto expressed concern over traffic and the Evans Avenue Quick-Build Project.

8. Citizens' Advisory Council Report

Michael Chen, Chair of the Citizens' Advisory Council, presented the report.

PUBLIC COMMENT:

Robert Marshall expressed concern over pedestrian safety on San Jose Avenue and urged the Board to support the CAC recommendation to address unsafe conditions in the corridor.

Daniel Thomas expressed support for the CAC recommendation and urged the SFMTA to act on the Vision Zero strategy.

9. Public Comment

Members of the public may address the SFMTA Board of Directors on matters that are within the Board's jurisdiction and are not on today's calendar.

Speaker asked that the Board inquire about what is happening with the taxi industry and expressed concern on the functions of the industry.

Speaker expressed concern over a parklet and impacts to a business on the block, including double parking.

Speaker expressed concern over parklet issues and blocking a business location.

Patricia Vaughey expressed concern over a parklet and blocking businesses in the area.

Hamilton Carter urged the SFMTA to reinstate the masking mandate and expressed concern over another surge during the fall and winter.

Speaker was happy to see the L Taraval bus back but expressed concern over frequency and not seeing it on Google maps.

Lisa Church commented on red zones at bus stops, sharing that a hearing for each stop is not needed and thanked staff for the increase in shuttle service at Golden Gate Park.

Hanny shared that he rides buses everyday and asked that the 28R 19th Avenue Rapid line be brought back.



Barry Taranto expressed concern over enforcement at taxi zones with the start of the Warriors season and reliable data collection.

Code Chapter 31: For identified Approval Actions, the Planning Department or the SFMTA has issued a CEQA exemption determination or negative declaration, which may be viewed online at the Planning Department's website. Following approval of the item by the SFMTA Board, the CEQA determination is subject to appeal within the time frame specified in S.F. Administrative Code Section 31.16 which is typically within 30 calendar days. For information on filing a CEQA appeal, contact the Clerk of the Board of Supervisors at City Hall, 1 Dr. Carlton B. Goodlett Place, Room 244, San Francisco, CA 94102, or call 415.554.5184. Under CEQA, in a later court challenge, a litigant may be limited to raising only those issues previously raised at a hearing on the project or submitted in writing to the City prior to or at such hearing, or as part of the appeal hearing process on the CEQA decision.
