SFMTA AWARDED GRANT TO CONTINUE 6TH YEAR OF MOTORCYCLE SAFETY PROGRAM

Vision Zero SF extends popular hands-on motorcycle safety trainings

SAN FRANCISCO - The San Francisco Municipal Transportation Agency (SFMTA) today announced that it received a \$60,000 grant from the California Office of Traffic Safety (OTS) to step up motorcycle safety. This grant supports the city's Vision Zero commitment to eliminate traffic deaths.

Grant funds will be used for a variety of activities promoting motorcycle safety and include:

- Participating in Motorcycle Safety Awareness Month in May.
- Partnering with the San Francisco Police Department to provide nine free hands-on motorcycle safety trainings, where riders can practice various urban safety skills and improve their defensive riding.
- Providing motorcycle clubs, shops, riders, and drivers educational material to increase awareness about motorcycle safety.

Each year in San Francisco, about 30 people lose their lives and over 500 more are severely injured while traveling on city streets. California has nearly 900,000 registered motorcycles. As vulnerable road users, motorcyclists are more likely to experience severe or fatal injuries when they are in a traffic crash. In San Francisco, motorcycle deaths continue to be overrepresented, comprising 30% of all traffic deaths in 2021, underscoring the need for more safety training and education.

This grant program runs from October 1, 2022 to September 30, 2023. Funding for this program was provided by a grant from the California Office of Traffic Safety, through the National Highway Traffic Safety Administration.
