Director Yekutiel shared that his focus this year would be on the state of the city's streets, commenting that the condition of the streets affects the SFMTA's ability to deliver excellent service and maintain the quality of SFMTA's busses.

PUBLIC COMMENT:

Speaker thanked the board for their work and hoped that the budget be prioritized for basic services, including the quality of the streets.

Aleta Dupree commented on why streets and the quality of streets are important.

Flo Kelly invited the Board to focus on tows.

Director Tumlin shared about the Annual Report, Central Subway Project opening, Muni service changes, weather related updates, a state budget update, upcoming events including MLK Day, Black History Month, Lunar New Year, the February 7 Board Workshop, and the Muni Art Project.



PUBLIC COMMENT:

Aleta Dupree looked forward to visiting the Central Subway and commented on equity for those most at risk on the Muni system.

Barry Taranto thanked Chair Borden for her service and shared that the Annual Report did not mention taxis and related enforcement issues.

8. Citizens' Advisory Council Report

Michael Chen, Chair, presented the report.

Eaken requested bringing back the Visitacion Valley recommendation when the related item comes before the Board.

PUBLIC COMMENT:

Barry Taranto expressed concern for paratransit taxi issues, sharing that issues need to be addressed sooner rather than later.

9. Public Comment

Members of the public may address the SFMTA Board of Directors on matters that are within the Board's jurisdiction and are not on today's calendar.

Flo Kelly expressed concern regarding parking regulations and signage.

Maggie Berkemeyer requested that the SFMTA include Chenery Street in the Slow Streets Network.

Kathy Richter urged the SFMTA to restore the 3 Jackson line.

Kevin Berkemeyer requested that the SFMTA reconsider Chenery Street as a Slow Street.

Speaker expressed concern regarding the 48 Quintara line on Tennessee Street and the challenges of parking along the street.

Jessica Jenkins expressed support to add Chenery Street to the Slow Streets Network.



Speaker expressed concern about the lack of enforcement of parked cars on Hardie Place and urged the SFMTA to monitor the illegal parking.

Speaker expressed concern about the 48 Quintara line running on Tennessee Street.

Michael Harris encouraged the Board to take a deep dive on the legacy of Rosa Parks and looked forward to an upcoming event at City Hall.

Herbert Weiner urged the SFMTA to restore all Muni lines and expressed concern about cyclists and scooters riding in the transportation lanes on the 49 Van Ness/Mission line.

Parker Day commented on Vision Zero and the High Injury Network (HIN) and encouraged the SFMTA to work diligently to get Polk Street off of the HIN in 2023.

Aleta Dupree looked forward to riding Muni soon and shared about meeting Director of Transportation, Jeffrey Tumlin.

Barry Taranto commented on a recent pedestrian fatality on 16th and Valencia Streets, expressing concern about double parking and visibility around shared spaces.

David Alexander expressed support for Chenery Street being added to the Slow Streets Program.

Trish Camp expressed support for Chenery Street and Page Streets being added to the Slow Streets Program and asked staff to improve Slow Streets signage.

Sarah Barns expressed support for Page and Chenery Slow Streets and asked the SFMTA to improve signage and treatments at the beginning and end of streets.

Nicholas Fewer expressed support for Chenery Street as a Slow Street and hoped that the SFMTA reconsider the street.

Following approval of the item by the SFMTA Board, the CEQA determination is subject to appeal within the time frame specified in S.F. Administrative Code Section 31.16 which is typically within 30 calendar days. For information on filing a CEQA appeal, contact the Clerk of the Board of Supervisors at City Hall, 1 Dr. Carlton B. Under CEQA, in a later court challenge, a litigant may be limited to raising only those issues previously raised at a hearing on the project or submitted in writing to the City prior to or at such hearing, or as part of the appeal hearing process on the CEQA decision.
