#### ORDER OF BUSINESS

#### 1 Call to Order

Chairman Nolan called the meeting to order at 1:00 p.m.

#### 2. Roll Call

3. Announcement of prohibition of sound producing devices during the meeting.

Chairman Nolan announced that the ringing of and use of cell phones, pagers and similar sound-producing electronic devices are prohibited at the meeting. He advised that any person responsible for the ringing or use of a cell phone, pager, or other similar sound-producing electronic devices might be removed from the meeting. He also advised that cell phones that are set on "vibrate" cause microphone interference and requested that they be placed in the "off" position.

## 4. Approval of Minutes

On motion to approve the minutes of the May 6, 2014 Regular Meeting: unanimously approved (Heinicke-absent).

#### 5. Communications

Board Secretary Boomer stated that there would be no discussion of anticipated litigation in closed session.

Chairman Nolan asked the Board Secretary to call Item 11 after Item 6.

6. Introduction of New or Unfinished Business by Board Members

Vice Chairman Brinkman requested a report regarding street widths.

Director Ramos requested information regarding platform heights and boarding along the Van Ness Bus Rapid Transit corridor.

## -Taxi Dispatch Data

Christiane Hayashi, Director, Taxis and Accessible Services, discussed electronic taxi dispatch.

Director Reiskin discussed introduction of a General Obligation Bond measure for the November 2014 ballot; Bike to Work Day and recent cycling improvements; Bay to Breakers service; LRV seat reconfiguration pilot project; Small Business Week and status of the Titan Ad contract.

#### **PUBLIC COMMENT:**

Herbert Weiner discussed the pilot to reduce the number of seats on light rail vehicles and inquired if this would provide for seating for all seniors and people with disabilities. The SFMTA needs more coaches and not this plan. Trains are crowded when there's only one coach. Bulb-outs cost \$300,000 each which could be used to buy more coaches. He would like to see a monthly report on bunching, breakdowns and other vital statistics.

Hansu Kim discussed electronic taxi dispatch and expressed appreciation for recognizing that new equipment wasn't needed. There is accountability now and the Regulator can see where vehicles are. This company has bragged that they would control taxi companies through equipment in the vehicles. He urged caution due to comments made in the past.

Tariq Mehmood discussed taxi dispatch. The SFMTA is throwing money away. It doesn't need to know how fast a taxi is going. It doesn't need a kill switch. The issue is with Uber and the money going out of his pocket.

Mark Gruberg stated that it was a missed opportunity by not having a single app that people can use. This is shortsighted.

Director Heinicke requested a report as to progress made towards electronic taxi dispatch.

## 8. Citizens' Advisory Council Report

#### 9. Public Comment

Herbert Weiner expressed concern that the panels saying when a bus arrives are not always accurate. This has to be straightened out. The SFMTA has proposed the near elimination of transportation along Clement Street. This is a street of small businesses from Arguello to 32<sup>nd</sup> Ave. The TEP is cutting access to small businesses which is a disservice to the city.

Hansu Kim stated that the taxi industry is about to go under and may have 18 months of life left. The industry can't compete against new forms of service that have no regulatory oversight or workers' compensation and pay nothing for insurance. Drastic measures are necessary now to save the industry.

Tariq Mehmood stated that FlyWheel is a great attempt but is not successful. Yellow Cab collected 5% without telling cab drivers they were collecting these credit card fees. They should be closed down. They failed the city and the public. Drastic measures are needed to stop Uber.

Mark Gruberg stated that Mr. Kim's concerns are most serious. The Board has approved and proceeded with the transfer value of a medallion and has precluded the possibility of lowering medallion fees. If medallion holders aren't paid enough, they can't make the payment and their loan will be foreclosed. Some companies have been charging 5% for credit card fees and have instituted a \$9.75 gate increase. This was supposed to come back to the Board but it is now in effect. He suggested wrapping the credit card fee into the gate fee.

Richard Hybels stated that cab companies are struggling and one will go out of business soon. There is a dire need for parking control officers at 2<sup>nd</sup> and Bryant as aggressive drivers pose a danger to pedestrians. There is a private trucking company that parks trailers at the park at the end of 24<sup>th</sup> St. all day and night. It's improper.

Chairman Nolan asked staff to look into the situation at the park on 24<sup>th</sup> St.

Director Rubke asked staff to provide feedback to the Enforcement Division about the situation at  $2^{nd}$  St. and Bryant.
