FOR PUBLIC HEARING

The Sustainable Streets Division of the San Francisco Municipal Transportation Agency will hold a public hearing on Friday, February 3, 2012, at 10:00 AM, in Room 416 (Hearing Room 4), City Hall, 1 Dr. Carlton B. Goodlett Place, San Francisco, CA 94102, to consider the following proposals:

ESTABLISH – NO PARKING ANYTIME

Boutwell Street, northerly terminus of the 100 block, from the projected west curb of the street to approximately 15.5' northeasterly (extends the existing No Parking Anytime restriction by 15.5')

ESTABLISH – RED ZONES

Bosworth Street, south side, from 0 feet to 26 feet west of Brompton Avenue (26 feet)

Bosworth Street, north side, from 5 feet to 25 feet east of Brompton Avenue (25 feet – removes 1 metered parking space #618)

Bosworth Street, south side, from 0 feet to 26 feet west of Hamerton Avenue (26 feet)

ESTABLISH – NO PARKING VEHICLES OVER 6 FEET HIGH

Thomas Street, north side, from 3rd Street to 100 feet easterly

ESTABLISH – RESIDENTIAL PERMIT PARKING AREA S, 2-HR PARKING, 8 AM TO 9 PM, MONDAY THROUGH FRIDAY

Noe Street - 1000 Block, both sides, between 23rd and Elizabeth Streets

ESTABLISH – NO VEHICLES GREATER THAN 6 FEET TALL

19th Street, south side, from Alabama St. (east intersection) to 100 feet westerly

19th Street, north side, from Alabama St. (west intersection) to 100 feet easterly

ESTABLISH – RED ZONE

19th Street, south side, from Alabama St. (prolongation of the east sidewalk of the west intersection) to 20 feet westerly

ESTABLISH – TRAFFIC ISLAND

7th Avenue at Moraga Street

ESTABLISH – NO U-TURN

Parnassus Avenue, eastbound at Hillway Avenue

ESTABLISH – 90 DEGREE PARKING

Head Street, east side, from Shakespeare Street to southern terminus

ESTABLISH – NO PARKING ANYTIME

Head Street, west side, from Shakespeare Street to Santa Barbara Avenue

ESTABLISH – NO PARKING

ESTABLISH – SIDEWALK WIDENING

18th Avenue, west side, from Irving Street to 20' northerly (widens sidewalk by 7')

18th Avenue, east side, from Irving Street to 21' southerly (widens sidewalk by 7')

Irving Street, south side, from 18th Avenue to 19' westerly (widens sidewalk by 7')

Irving Street, north side, from 18th Avenue to 19' easterly (widens sidewalk by 7') (Removes meter 1622)

Judah Street, south side, from 17th Avenue to 17' westerly (widens sidewalk by 6')

Judah Street, north side, from 17th Avenue to 24' - 7" easterly (widens sidewalk by 6')

ESTABLISH – RED ZONE

17th Avenue, east side, from Judah Avenue to 15 feet southerly

ESTABLISH – 35 MILE PER HOUR SPEED LIMIT

Sloat Boulevard between 19th Avenue and Everglade Drive (existing speed limit is 40 miles per hour)

ESTABLISH – COMPACT PARKING

Haight Street, north side, from 6' to 21' east of the western intersection with Cole Street (reduces stall #1698 from 19' long to 15' long)

ESTABLISH – 3 METERED MOTORCYCLE PARKING STALLS

Haight Street, north side, from 77 feet east of Masonic Avenue to 90 feet east of Masonic Avenue
