FOR PUBLIC HEARING

The Sustainable Streets Division of the San Francisco Municipal Transportation Agency will hold a public hearing on Friday, July 26, 2013 at 10:00 AM, in Room 416 (Hearing Room 4), City Hall, 1 Dr. Carlton B. Goodlett Place, San Francisco, CA 94102, to consider the following proposals:

ESTABLISH - METERED LOADING ZONE, 7AM TO 6PM, MONDAY THROUGH FRIDAY
267 8th Street, east side, from 24 feet to 61 feet north of Clementina Street, at parking meter stalls 235 and 237 (37-foot zone)

ESTABLISH - METERED LOADING ZONE, 7AM TO 4PM, MONDAY THROUGH FRIDAY
"398" Divisadero Street, east side, from 13 feet to 62 feet south of Oak Street, at parking meter stalls 326 and 328 (49-foot zone)

ESTABLISH – GREEN ZONE, 9AM TO 6PM, MONDAY THROUGH SATURDAY
"400" Scott Street, east side, from 0 feet to 18 feet north of crosswalk line (18-foot zone)

ESTABLISH – BLUE ZONE
"2199" Broadway Street, south side, from 0 feet to 20 feet east of Webster Street (20-foot zone)

ESTABLISH – SIX-WHEEL LOADING ZONE, 8AM TO 6PM, MONDAY THROUGH FRIDAY
199 Mississippi Street, east side, from 0 feet to 36 feet south of the north property line (36-foot zone)

REVOKE – PART-TIME PASSENGER LOADING ZONE, 8AM TO 10AM AND 2PM TO 4PM, MONDAY THROUGH FRIDAY
1500 Howard Street, north side, from 2 feet to 82 feet west of 11th Street, at parking meter stalls 1502, 1504, 1508 and 1510 (80-foot zone)

ESTABLISH – PART-TIME PASSENGER LOADING ZONE, 7AM TO 10AM AND 1PM TO 4PM, MONDAY THROUGH FRIDAY
1500 Howard Street, north side, from 2 feet to 122 feet west of 11th Street, at parking meter stalls 1502, 1504, 1508, 1510, 1512 and 1514 (120-foot zone)

REVOKE – SIX-WHEEL METERED LOADING ZONE, 7AM TO 6PM, MONDAY THROUGH FRIDAY

ESTABLISH – METERED LOADING ZONE, 7AM TO 6PM, MONDAY THROUGH FRIDAY
657 Sutter Street, south side, from 169 feet to 191 feet east of Taylor Street, at parking meter 625 (22-foot zone)

ESTABLISH- BLUE ZONE

700 Pennsylvania Ave, west side, from 0 feet to 13 feet south of 22nd Street (13-foot zone)

ESTABLISH - GREEN ZONE, 9AM TO 6PM, MONDAY THROUGH SATURDAY

293 Bayshore Blvd, east side, from 0 feet to 22 feet north of the south property line (22-foot zone)

ESTABLISH - METERED LOADING ZONE, 7AM TO 6PM, MONDAY THROUGH SATURDAY

Geary Street, north side, from 104 feet to 144 feet west of 9th Avenue, at meters 4512 and 4516 (40-foot zone)

ESTABLISH - SHUTTLE BUS ZONE, 11AM TO 7PM, MONDAY THROUGH FRIDAY (10-MINUTE TIME LIMIT)

"801" Beach Street, south side, from 0 feet to 63 feet west of Larkin Street, at parking meter stalls 801, 803 and 805 (63-foot zone)

Public hearings are held once a month at City Hall to legislate the installation of new colored zones. The zones usually recommended for this process are blue, green, white, and yellow. The purpose of the hearing is for residents to express their concerns regarding proposed changes affecting their streets. All interested parties are encouraged to attend. At the Public Hearing, the Hearing Officer will review the items and listen to residents, then make a final decision. Upon approval and payment of any applicable installation fees, zones will be installed as soon as scheduling permits.
