RESOLUTION No. 15-026

WHEREAS, The San Francisco Municipal Transportation Agency has received a request, or identified a need for traffic modifications as follows:

ESTABLISH – TOW-AWAY NO STOPPING EXCEPT PERMITTED CAR SHARE VEHICLES –

- A. 15th Street, south side, from Dolores Street to 38 feet westerly (38-foot zone, for 2 car share parking permit spaces--C022 & C124)
- B. 22nd Street, south side, from Noe Street to 36 feet easterly (36-foot zone, for 2 car share parking permits--Z075 & Z150)
- C. 24th Street, north side, from 18 feet to 38 feet west of Chattanooga Street (20-foot zone removes Post ID #224-37520, for 1 car share parking permit space--G160)
- D. 29th Street, north side, from Dolores Street to 17 feet easterly (17-foot zone, for 1 car share parking permit space--C090)
- E. 42nd Avenue, east side, from Balboa Street to 35 feet northerly (35-foot zone, for 2 car share parking permits--Z006 & Z091)

WHEREAS, The proposed on-street car share parking modifications are subject to environmental review under the California Environmental Quality Act (CEQA); and,

WHEREAS, On May 31, 2013, the Planning Department determined that the on-street car share pilot program was categorically exempt from environmental review under Class 6 (information collection activities which do not result in a serious or major disturbance to an environmental resource); and,

WHEREAS, This determination was referenced as part of the SFMTA Board's approval of the on-street car share pilot program in SFMTA Board Resolution No. 13-185 on July 16, 2013; and,

WHEREAS, The two-year pilot program will include qualified car share organizations who will be permitted exclusive and conditional use of on-street parking spaces in exchange for providing various data to evaluate the feasibility and effectiveness of on-street car sharing spaces; and,

WHEREAS, Designated on-street car share parking spaces must be approved by the SFMTA Board of Directors as required by the Transportation Code; and,

WHEREAS, The public has been notified about the proposed modifications and has been given the opportunity to comment on those modifications through the public hearing process; now, therefore, be it,

RESOLVED, That the San Francisco Municipal Transportation Agency Board of Directors establishes Tow-Away No Stopping Anytime Except Permitted Car Share Vehicles at the following locations:

- A. 15th Street, south side, from Dolores Street to 38 feet westerly (38-foot zone, for 2 car share
