BRIEF DESCRIPTION:

Amending the Transportation Code Division II to adopt proposed parking restrictions and approving parking and traffic modifications.

SUMMARY:

- Since the SFMTA manages on-street parking throughout the City, City Hall Building Services and the General Services Agency's Fleet Management/Central Shops division are requesting the SFMTA to enact parking restrictions to support their operations.
- The proposed action is the Approval Action as defined by S. F. Administrative Code Chapter 31.

PURPOSE

Amending the Transportation Code, Division II, to revise parking restrictions at various locations.

STRATEGIC PLAN GOALS AND TRANSIT FIRST POLICY PRINCIPLES

The proposed amendment to the Transportation Code supports the SFMTA Strategic Plan Goals and Objectives indicated below:

- Goal 1: Create a safer transportation experience for everyone Objective 1.2: Improve workplace safety and security
- Goal 3: Improve the environment and quality of life in San Francisco Objective 3.3: Allocate capital resources effectively Objective 3.4: Deliver services efficiently Objective 3.5: Reduce capital and operating structural deficits

The proposed amendment to the Transportation Code also supports the SFMTA Transit-First Policy principle indicated below:

Principle 1: To ensure quality of life and economic health in San Francisco, the primary objective of the transportation system must be the safe and efficient movement of people and goods.

DESCRIPTION

The proposed Transportation Code amendments will revise parking restrictions at three locations. One is the permitted parking spaces surrounding City Hall along Grove Street, Dr. Carlton B. Goodlett Place, and McAllister Street. The other two locations are fronting two new General Services Agency Fleet Management/Central Shops facilities in the Bayview district located at 555 Selby Street and 450 Toland Street.

Currently, the permit spaces surrounding City Hall are used by government officials and employees and the parking restrictions are codified in the Transportation Code. City Hall Building Services has requested the SFMTA to revise the existing permit parking hours to better serve City Hall officials and employees in concert with access controls to the building. The proposed timing changes will only affect existing permitted spaces. The parking modifications are as follows:

- A. ESTABLISH PERMIT PARKING, 6 AM TO 7 PM, MONDAY THROUGH FRIDAY Grove Street, north side, between Van Ness Avenue and Polk Street (360-foot zone, accommodating 25 angled parking stalls); Grove Street, south side, from 266 feet to 358 feet east of Van Ness Avenue (92-foot zone, accommodating 4 parallel parking stalls); Dr. Carlton B. Goodlett Place, east side, from 32 feet to 150 feet north of Grove Street (118-foot zone, accommodating 10 angled parking stalls)
- B. ESTABLISH PERMIT PARKING, AT ALL TIMES Dr. Carlton B. Goodlett Place, west

side, between McAllister Street and Grove Street (531-foot zone, accommodating 20 parallel parking stalls); McAllister Street, south side, from 137 feet to 287 feet east of Van Ness Avenue (150-foot zone, accommodating 13 angled parking stalls)

There is an ongoing capital improvement project to relocate the General Service Agency's Fleet Management/Central Shops division from its current facility at 1800 Jerrold Avenue to two new facilities in the Bayview district. The Fleet Management/Central Shops division is responsible for maintaining approximately 7,000 vehicles and has an operational capacity of approximately 1,700 vehicle services per month. Combined, the square footage at the two new sites is 22% less than the existing site. The square footage reduction and separation of the facility will cause on-site constraints to vehicle maintenance operations and will require City vehicles to be parked on the street. In anticipation of these future constraints, the project manager for the Fleet Management/Central Shops facility relocation project is requesting the following parking modifications fronting the buildings only to facilitate operations without adversely impacting the surrounding roadway network:

C. ESTABLISH – NO PARKING ANYTIME, EXCEPT CITY-OWNED VEHICLES MAINTAINED BY CENTRAL SHOPS – Selby Street, east side, from Hudson Avenue to Galvez Avenue; Toland Street, west side, from 100 feet to 350 feet north of Jerrold Avenue

Signage will be installed at the above locations to notify the public. In order to restrict parking at these locations, an amendment to the Transportation Code is required.

STAKEHOLDER ENGAGEMENT

In accordance with SFMTA procedures, public hearings were held to consider the proposed changes. The public hearing for the City Hall locations was held on May 5, 2017. The public hearing for the Fleet Management/Central Shops building locations was held on November 3, 2017.

A notice indicating the public hearing date, time, location, and purpose was posted in the area affected by these parking restrictions at least one week in advance of the hearing date. No public comments were received either in favor or against the proposed modifications for City Hall at the May 5, 2017 public hearing. There was one comment of opposition to the modifications in the Bayview district at the November 3, 2017 public hearing. As the comment concerned a general complaint regarding homelessness in the City and not specific to the proposed parking modifications, SFMTA staff decided to proceed with the proposed parking restrictions.

ALTERNATIVES CONSIDERED

The only alternative considered is to not enact these proposed parking restrictions. Staff decided to proceed with the proposed restrictions to better serve City Hall officials and employees in concert with access controls to the building and to facilitate Fleet Management/Central Shops operations without adversely impacting the surrounding roadway network

FUNDING IMPACT

The fabrication, installation, and maintenance costs for the metal signs will be approximately \$18,000 and is budgeted in the SFMTA's existing operating budget.

ENVIRONMENTAL REVIEW

The proposed parking and traffic modifications are subject to the California Environmental Quality Act (CEQA). Title 14 of the California Code of Regulations Section 15301 provides an exemption from environmental review for the operation, repair, maintenance, or minor alteration of existing highways and streets, sidewalks, gutters, bike and pedestrian trails, and similar facilities.

On April 21, 2017, the SFMTA, under authority delegated by the Planning Department, determined (Case No. 2017-005624ENV) that the proposed parking and traffic modifications for the permit parking changes at City Hall are categorically exempt from CEQA pursuant to Title 14 of the California Code of Regulations Section 15301. On January 5, 2018, the Planning Department determined (Case No. 2018-000726ENV) that the proposed parking and traffic modification related to the Fleet Management/Central Shops locations are categorically exempt from CEQA pursuant to Title 14 of the California Code of Regulations Section 15301. The proposed action is the Approval Action as defined by S. F. Administrative Code Chapter 31.

Copies of the CEQA determinations are on file with the Secretary to the SFMTA Board of Directors, may be found in the records of the Planning Department at 1650 Mission Street in San Francisco, and are incorporated herein by reference.

OTHER APPROVALS RECEIVED OR STILL REQUIRED

The City Attorney's Office has reviewed this calendar item.

- C. ESTABLISH NO PARKING ANYTIME, EXCEPT CITY-OWNED VEHICLES MAINTAINED BY CENTRAL SHOPS – Selby Street, east side, from Hudson Avenue to Galvez Avenue; Toland Street, west side, from 100 feet to 350 feet north of Jerrold Avenue

WHEREAS, The public has been notified about the proposed modifications and has been given the opportunity to comment on these modifications through the public hearing process; and,

Resolution amending Division II of the Transportation Code to prohibit parking at various locations.

The Municipal Transportation Agency Board of Directors of the City and County of San Francisco enacts the following regulations:

Section 1. Article 800 of Division II of the Transportation Code is hereby amended by revising Section 801, to read as follows:

SEC. 801. PARKING RESTRICTIONS BY LOCATION.

In enacting this ordinance, the San Francisco Municipal Transportation Agency Board of Directors intends to amend only those words, phrases, paragraphs, subsections, sections, articles, numbers, letters, punctuation marks, charts, diagrams, or any other constituent parts of the Transportation Code that are explicitly shown in this ordinance as additions or deletions in accordance with the "Note" that appears under the official title of the ordinance.
