6. Public Comment:

Edward Mason inquired if the SFMTA is tracking development in the City. The Transportation Sustainability Fee should be looked at. The SFMTA should investigate whether they need to continue to fund training for the Bicycle Coalition. It doesn't seem to be effective. He stated that the Santa Clara Valley Transportation Authority is trying to replicate the Commuter Shuttle Bus program. The SFMTA needs to look at how they apply shuttle fees for the use of bus zones and operating in the City. He is baffled at how Muni has grown to 6000 employees.

The SFMTA CAC urges the SFMTA Board of Directors to hold a public hearing before April 17 on fee setting for commuter shuttles and private transportation vehicles that use City streets as places of enterprise for private gain to consider establishing additional, non-regulatory, revenue generating fees for the benefit of the SFMTA. A privileged and confidential City Attorney 2013 memo exists that addresses the matter of fees that can be charged for use of city streets as places of enterprise for private gain. Publicly available evidence indicates that the SFMTA can charge more.

PUBLIC COMMENT:

Mark Miller stated that asking the SFMTA Board of Directors to have a public hearing on something that is beyond cost recovery is a moot point without the memo. There is a legal finding of fact by the Board of Supervisors that says the Commuter Shuttle Bus program is a voluntary program. There's a statement in Muni's bond offerings from 2014 that says voluntary programs are Prop 26 exempt. The SFMTA Board of Directors cannot have a public

hearing on a fee and say it is Prop 26 restricted, then say it's voluntary, and then say voluntary fees are Prop 26 exempt. All three of these things cannot be true. He urged the committee to put back into the motion the request that asks for attorney client privilege to be waived. The public record is faulty. He stated that he doesn't see the point of asking for the hearing without the additional information.

Motion 180221.09

The SFMTA CAC recommends that the SFMTA use some population-based Prop B funds for operating instead of capital. Future capital projects should have operations costs factored into their budgets.
