BRIEF DESCRIPTION:

Approving various routine parking and traffic modifications.

SUMMARY:

- The SFMTA Board of Directors has authority to adopt parking and traffic regulations changes.
- Taxis are not exempt from any of these regulations.
- The proposed parking and traffic modifications have been reviewed pursuant to the California Environmental Quality Act (CEQA).
- The proposed action is the Approval Action for Items A-Z and Item CC as defined by S.F. Administrative Code Chapter 31.
- The "PH" date refers to the date that the SFMTA held a public hearing pursuant to the requirements established in Transportation Code, Division II, Sections 201 and 202. If a public hearing date is not provided, the public hearing for the proposed modifications will be held at the SFMTA Board and posted in accordance with the provisions of Transportation Code, Division II, Section 202.

PURPOSE

To approve various routine parking and traffic modifications.

STRATEGIC PLAN GOALS AND TRANSIT FIRST POLICY PRINCIPLES:

ENVIRONMENTAL REVIEW

The proposed parking and traffic modifications are subject to the California Environmental Quality Act (CEQA). CEQA provides a categorical exemption from environmental review for operation, repair, maintenance, or minor alteration of existing highways and streets, sidewalks, gutters, bicycle and pedestrian trails, and similar facilities as defined in Title 14 of the California Code of Regulations Section 15301.

The SFMTA, under authority delegated by the San Francisco Planning Department, has determined that the proposed parking and traffic modifications in Items A-W, Y-Z (Case No. 2018-011169), and Item CC (Case No. 2018-011585) are categorically exempt from CEQA pursuant to Title 14 of the California Code of Regulations Section 15301.

The San Francisco Planning Department has determined that the proposed parking and traffic modifications in Item X (Case No. 2015-005492) are categorically exempt from CEQA pursuant to Title 14 of the California Code of Regulations Section 15303.

The proposed parking and traffic modifications in Items AA-BB are within the Western SoMa Community Plan Area, for which the environmental impacts were analyzed in the Western SoMa Final Environmental Impact Report (Western SoMa FEIR). On December 6, 2012, the San Francisco Planning Commission in Motion 18756 certified the FEIR (Case No. 2008.0877E and 2007.1035E), and adopted CEQA Findings including a Mitigation Monitoring and Reporting Program pursuant to CEQA. The San Francisco Planning Department has determined that the proposed parking and traffic modifications in Items AA-BB (Case No. 2013.1390E) are consistent with the Western SoMa FEIR and are therefore exempt from CEQA pursuant to Title 14 of the California Code of Regulations Section 15183. No new significant effects have been identified, there is no substantial increase in significant effects already identified, and no new mitigation is required for the projects.
