PURPOSE

The purpose of this calendar item is to establish a meeting schedule for the SFMTA Board of Directors/Parking Authority Commission and the Policy and Governance Committee for 2019.

STRATEGIC PLAN GOALS AND TRANSIT FIRST POLICY PRINCIPLES

Adopting a proposed schedule for meetings does not directly forward any of the SFMTA's Strategic Plan Goals nor Transit First Policy Principles but it supports all goals and principles.

DESCRIPTION

Establishing a meeting schedule will allow staff to manage their work flow in a more time and cost effective manner and will help to ensure smooth approval and delivery of projects.

Pursuant to the SFMTA Board of Directors Rules of Order, the Board has established regular meeting dates on the first and third Tuesday of every month. The Policy and Governance Committee (PAG) meets on the fourth Tuesday of each month.

Traditionally, certain meetings have been cancelled during the year. For 2019, staff recommends that the meetings of January 1, July 2, August 6, and December 17 not be held.

In 2019, all Memoranda of Understanding (MOU) with San Francisco's labor unions will be negotiated. The SFMTA is responsible for bargaining directly with the following:

- 1. TWU 250-A (9163) Operators
- 2. TWU 250-A (9132) Transit Fare Inspectors
- 3. TWU 250-A (7410) Automotive Service Workers
- 4. TWU Local 200 for Service Critical Classifications

Because MOUs must be approved by the SFMTA Board of Directors not later than June 30, 2019, we recommend tentatively scheduling a meeting on Friday, June 28, should a meeting be necessary.

In addition to the regular meeting schedule, during a year when MOU's are being negotiated, we tentatively schedule a series of closed sessions during negotiations so the labor negotiator can meet with the Board. Those meetings would be held on alternate Tuesdays in March, April and May at One South Van Ness Ave. Because these meetings would be in a location that is not your normal meeting room, the Sunshine Ordinance requires 15-day notice, therefore, it is best to schedule them and then cancel if not necessary.

Should additional meetings need to be scheduled, Article 4, Section 2 of the SFMTA Board's Rules of Order state that special meetings may be called at any time by the Chairman or by a majority of Board members as long as at least 72 hours advance notice is given.

Once approved by the SFMTA Board of Directors, the meeting schedule will be posted on-line and notice for all meetings will be posted in accordance with public meeting laws.

In addition to the proposed schedule of meetings below, additional special closed sessions will be schedule for conferences with the SFMTA's labor negotiator, as noted in the table below.
