#### **BRIEF DESCRIPTION:**

Correcting Resolution No. 181204-151, to approve Amendment No. 2 to Contract No. SFMTA-2011/12-30 (As-Needed Specialized Engineering Services for SFMTA Rubber Tire Vehicle Projects) with Jacobs Engineering Group, Inc., for an amount not to exceed \$2,250,000 (instead of \$2,500,000), and a total Contract amount not to exceed \$8,500,000.

#### **SUMMARY:**

- On June 4, 2013, the SFMTA entered into a contract with Jacobs Engineering Group, Inc. (the Contractor) for as-needed engineering services for rubber tire vehicle projects (Contract). The Contract was for an amount not to exceed \$5,000,000 and for a term up to six years.
- On November 27, 2017, the SFMTA issued Contract Amendment No. 1 to increase the contract amount to \$6,250,000 (25% increase) and extend the term of the Contract from six years to seven years and six months so that the Contractor can continue as-needed engineering services for rubber tire vehicle procurements.
- On December 4, 2018, the SFMTA Board approved Contract Amendment No. 2 to increase the contract amount by \$2,500,000 to a total contract amount not to exceed \$8,500,000 under Resolution No. 181204-151.
- Resolution No. 181204-151 contained a typographical error—the increase to the Contract amount should have been \$2,250,000 instead of \$2,500,000. The total Contract amount remains at \$8,500,000.
- This resolution corrects the error.
