6. Public Comment:

Edward Mason provided an update on the commuter shuttle program in Noe Valley. Last week, there was a double-decker WeDriveU bus stalled on the grade on westbound 24th Street at Dolores Street, which caused a Muni delay. Mr. Mason called 311 to report it. The shuttle bus providers are not self-reporting when there is an incident. As the bus was being towed away, it and created a large scrape in the payement on Dolores Street.

Sharon Lai stated that she along with another woman experienced a sexual battery incident on a Muni train on Monday, March 25th. She reported the incident to the SFPD and the SFMTA. She was surprised to learn that sexual crimes are common and under reported on Muni vehicles. She stated that she did not realize there was an emergency button nor did she know its purpose. It would have been helpful to know that had she pushed the button, the Operator would have called the train to a stop and called the police. She also did not realize that there are train identification numbers that she should have noted. They seem to be in obscure places. It is SFMTAs responsibility to reach the riders and let them know what tools are at

their disposal. She urged the CAC to encourage the SFMTA to do a comprehensive assessment of women's safety on Muni vehicles and the SFMTA's responsibility in maintaining safety on their vehicles.
