4. Public Comment

Edward Mason provided a report on commuter shuttles at Valley and San Jose Streets. There is a 30-foot stop at that location and there were 36 buses there in one hour. Buses are there before 6:00 am and they are disturbing the neighbors. There is congestion at 24th and Church where there are two white zone spaces for two buses but then a third arrives and contributes to the 160 buses a day. Also the Siemens cars' air conditioning isn't working and people are clustering at exits and they don't move to the center.

5. Presentation, discussion and possible action regarding key metrics and actions for SFMTA Strategic Plan Goals including safety, operations and finance. (Explanatory documents include a slide presentation.)

Ed Reiskin, Director of Transportation, and various staff presented the report.

PUBLIC COMMENT:

Edward Mason discussed the cost of emerging technology and possible liability issues. Computerized delivery services could have an impact on pedestrian safety. There should be legislation to have that responsibility be on the developers.
