


Geary Rapid Project

The first phase of construction as part of the <u>Geary Rapid Project</u> continues. Work to replace aging water and sewer lines between Masonic Street and Van Ness Avenue is scheduled to be done in coordination with the San Francisco Public Utilities Commission (SFPUC).

- Water main installation, connection and testing is planned for the weeks of October 21 and October 28 on Geary Street between Van Ness and Hyde streets.
- Sidwalk and roadway work is planned for the weeks of October 14 and October 21 at the south east corner of the intersection of O'Farrell and Larkin streets.
- Beginning Friday, October 25 the inbound 38 Geary bus stop at O'Farrell and Larkin streets will be permanently relocated to the east side of the intersection.


