- CEQA
 - Project application submitted in November, 2019
 - CEQA scoping meeting in March, 2020
 - Draft EIR year end, 2020; early 2021
 - 22-month CEQA approval from "stable project description"
- RFP release
 - Summer, 2020
- Developer selection
 - Fall, 2020
- Outreach in 2020
 - Working group meetings every month (Doodle poll!)
 - Outreach event in March, another event in June
 - Muni employee outreach
 - Community events, tabling, and presentations
 - Ongoing community engagement throughout the CEQA, RFP development and planning entitlements process
