Vice Chair Borden called the meeting to order at 1:00 p.m.

## 2. Roll Call

3. Announcement of prohibition of sound producing devices during the meeting.

Board Secretary Boomer announced that the ringing of and use of cell phones, pagers and similar soundproducing electronic devices are prohibited at the meeting. She advised that any person responsible for the ringing or use of a cell phone, pager, or other similar sound-producing electronic devices might be removed from the meeting. She also advised that cell phones that are set on "vibrate" cause microphone interference and requested that they be placed in the "off" position.

4. Approval of Minutes

On motion to approve the minutes of the November 19, 2019 Regular Meeting: unanimously approved (Brinkman, Heinicke, and Torres absent).

6. Introduction of New or Unfinished Business by Board Members

7. Director's Report (For discussion only)

-Special Recognition -Update on Vision Zero -Ongoing Activities Tom Maguire, interim Director of Transportation recognized Wyman Lee, resident engineer, Central Subway Project.

Mr. Maguire discussed Vision Zero fatalities, service disruptions, work of the Mayor's Transit Working Group; Bay Wheels, fare increases, and free Muni on New Year's Eve.

Vice Chair Borden asked for information regarding how often wires in the subway are inspected.

Director Heminger requested information regarding the causes of pedestrian fatalities. Director Maguire stated that the police department's report would be provided to the Board.

#### PUBLIC COMMENT:

Herbert Weiner would like to see a report from the Department of Parking and Traffic. The report would be useful. The public hasn't been included in the Mayor's taskforce. The data will be skewed because only certain individuals participated. The police could participate with the Dept. of Parking and Traffic.

8. Citizens' Advisory Council Report

No report.

9. Public Comment

John Paar discussed the outer Sunset. The SFMTA did a wonderful job painting lines in an area covered by fog, which is useless. The problem wasn't solved. The Judah Street train story doesn't have a good ending. A passenger exiting a train can get flattened by a car. He asked the Board to allocate \$20 million to build a proper station and save lives.

Alex April thanked SFMTA staff for the scooter permit program. She discussed how Spin is addressing improper sidewalk parking. Sidewalk riding is against the law. Spin scooters have signs on each vehicle and offers a valet service at some locations. This has drawn a lot of new users.

Herbert Weiner discussed Muni Forward. The 27-bus run was altered, and bus stops were removed. There was no addition of coaches to that run. It was done to make buses run faster but the service is still lousy, and people must walk longer distances. The public is lost in public transportation. Muni Forward was flawed from the beginning. The sentiments of the neighborhood affected by a change must be consulted.

(10.2) Approving the following traffic modifications:

- A. ESTABLISH RED ZONE Washington Street, south side, from Mason Street to 30 feet easterly.
- B. ESTABLISH RESIDENTIAL PERMIT PARKING AREA S ESTABLISH 2-HOUR PARKING, 8 AM TO 9 PM, MONDAY THROUGH FRIDAY, EXCEPT VEHICLES WITH AREA S PERMITS; Dolores Street, east side, between 19th Street and Cumberland Street.
- C. ESTABLISH 15 MILES PER HOUR SCHOOL SPEED LIMIT WHEN CHILDREN ARE PRESENT — Golden Gate Avenue, between Hyde Street and Leavenworth Street; Golden Gate Avenue, between Leavenworth Street and Jones Street
- D. ESTABLISH 25 MILES PER HOUR SCHOOL SPEED LIMIT WHEN CHILDREN ARE PRESENT Visitacion Avenue, between Mansell Street and Hahn Street.
- E. ESTABLISH NO PARKING ANYTIME Harrison Street, south side, from Spear Street to 29 feet easterly, and making environmental review findings. (Explanatory documents include a staff report and resolution. For every parking and traffic modification that received a categorical exemption, the proposed action is the Approval Action as defined by Chapter 31 of the San Francisco Administrative Code.)

Ali Ghani discussed taxi medallions. The industry is dead. The taxi companies profit but taxi drivers have lost everything and are exhausted. The Board needs to do something. Drivers want to be bought out. The medallion program should go away.

<u>California Environmental Quality Act (CEQA) Appeal Rights under S.F. Admin. Code Chapter 31</u>: For identified Approval Actions, the Planning Department or the SFMTA has issued a CEQA exemption determination or negative declaration, which may be viewed online at the Planning Department's website. Following approval of the item by the SFMTA Board, the CEQA determination is subject to appeal within the time frame specified in S.F. Administrative Code Section 31.16 which is typically within 30 calendar days. For information on filing a CEQA appeal, contact the Clerk of the Board of Supervisors at City Hall, 1 Dr. Carlton B. Goodlett Place, Room 244, San Francisco, CA 94102, or call (415) 554-5184. Under CEQA, in a later court challenge, a litigant may be limited to raising only those issues previously raised at a hearing on the project or submitted in writing to the City prior to or at such hearing, or as part of the appeal hearing process on the CEQA decision.

<u>Board of Supervisors review of certain SFMTA Decisions</u>: Certain parking and traffic modifications as well as Private Transportation Programs that involve certain parking modifications can be reviewed by the Board of Supervisors. These decisions are subject to review within 30 calendar days after they are made by the SFMTA Board of Directors.
