8. Resolution – Increase SF Enforcement of Traffic Regulations

Jon Winston and Gabrielle Haug

- Increase enforcement with additional regulations
- Increase traffic enforcements related to pedestrian safety incidents, such as blocking intersections, traveling over city speed limits, running red lights, making illegal turns, and other illegal activities.
- Suggested amendment: Include all of Focus on the 5
 - o E.g. Failure to yield to pedestrian in a sidewalk
- Suggested amendment: Include specificity with numbers, including decreased numbers of citations over time and lack of resources related to hiring of SFPD officers.
- Suggested amendment: Change final phrase in last WHEREAS to either strike language or change the tone of the language related to income/funds

 - o Confused on certain language, such as scurrying pedestrians
 - Confusion on potential jurisdictional issues related to this resolution
 - Concerns on specificity of safety vs quickly
 - o Comments related to positive educational efforts included in the resolution
 - Appreciate things that will speed MUNI up
 - Noting that pedestrians have the right of way
