We hereby petition SFMTA Sustainable Streets: Parking to perform the necessary surveys, hold public hearings, and recommend to the SFMTA Board of Directors that this area be designated as an RPP Area. We understand that if the proposed area is designated an RPP Area, the following parking regulations would become effective:

- Permits are limited to one per driver and two per household; additional drivers may petition the SFMTA for additional permits
- Posted time-limited parking during the designated days and hours with exemption for residents and businesses whose vehicles display a valid sticker.
- Commercial vehicles with a Gross Vehicle Weight Rating (GVWR) of 6,000 lbs. or more are not eligible for a Permit.
