






Project Schedule

Phases 1C and 1D underway. Expected completion summer 2020



Construction update

- Wrapping up Utilities Phase
 - Joint trenching, utility conflicts, sidewalk replacement, street base repair and paving work, sewer and water installation
- Shifting to BRT Buildout Phase this summer
 - Construction in middle of the roadway
 - Construction of red transit-only lanes, median islands, landscaping, bus shelters, bulb-outs, pole setting installations

Geary Rapid Project

As part of the Geary Rapid Project, work to replace aging water and sewer lines between Masonic Street and Van Ness Avenue, in coordination with the San Francisco Public Utilities Commission, continues. Transportation improvements, including upgraded traffic signals and streetlights, sidewalk extensions at bus stops and intersection corners, improved median refuges and roadway repaving, have also started and are being managed by San Francisco Public Works.
