5. Report of the Chair (For discussion only)

6. Public Comment:

Ken Koblenzer asked about the state of the Geary BRT project. He is concerned about the center running bus lane design.

David Pilpel expressed concern about the confusing stops on Market Street for the L, T, and N lines. There was an attempt by staff to improve signage and make announcements, but the signs don't stay up and are confusing for passengers. The shuttles should stop at all islands at all times. It would make it easier for everyone. Operation has been choppy and difficult. Operators are doing a good job but there is a lot going on out there. It would be good to know if the agency has a way to deal with people who are homeless or have behavioral health issues. There is an increasing amount of the ridership that could be described that way.

7. Presentation, discussion, and possible action regarding the SFMTA Transportation Recovery Plan. (Ian Trout, Associate Engineer, Transit Engineering Group. Explanatory documents include a slide presentation.)

Ian Trout, Associate Engineer, Transit Engineering Group, discussed the approach, values, goals, challenges, and next steps of the SFMTA Transit Recovery Plan.

# **PUBLIC COMMENT:**

Ken Koblenzer said he is high risk, so he is living in his apartment. He's a big fan of Slow Streets. There seems to be no supervision of what is happening on the slow streets. He stated that he hears a lot of controversy. He sees a lot of people outside not wearing masks or social distancing. SFPD and DPH should be doing outreach and public education around wearing masks and social distancing. He drove SF taxis for about 14 years and still knows a lot of taxi drivers. He wondered whether the SFMTA is mandating any taxi cleaning practices.

David Pilpel stated that he appreciated the presentation. There hasn't been a lot of public discussion about the recovery plan. He strongly urged that the SFMTA set up a place on the website for the transportation recovery plan where they can put a little more information on each element of the plan and create a way for two-way engagement. There needs to be meaningful public engagement. Passengers with behavioral health issues continue to be an ongoing challenge and should be addressed in the recovery plan. There should be an amendment to the transportation code to make failure to follow a public health order a citable violation.

Shahin Saneinejad stated that virtual meetings are much easier for him to attend. He stated that there is a lot of value in the Slow Streets program and its swift start. He inquired what the status of Slow Streets is in Ingleside.

Roan Kattouw stated that the SFMTA should not be afraid to move ahead boldly and quickly with Slow Streets and the emergency transit lane proposal. He urged the CAC to support the transit lane proposal and the building out of a lot more transit lanes.

# CAC MOTION 200604.01

Given the SFMTA's vital role in supporting the City's response to the pandemic, and given the major changes to mass transit schedules and routes to support the need for social distancing, the SFMTA CAC recommends that the SFMTA establish a policy of making proactive sidewalk parking enforcement, on sight and without citizen request, a top priority for PCOs, given the difficulty for pedestrians in maintaining social distancing on sidewalks where illegally parked cars are encroaching onto pedestrian space.

The CAC recommends that this information is shared to the public on the SFMTA Slow Streets webpage.
