### **Geary Rapid Project**

As part of the <u>Geary Rapid Project</u>, work to replace aging water and sewer lines between Masonic Street and Van Ness Avenue, in coordination with the San Francisco Public Utilities Commission, continues. Transportation improvements, including upgraded traffic signals and streetlights, sidewalk extensions at bus stops and intersection corners, improved median refuges and roadway repaving, have also started and are being managed by San Francisco Public Works.
