5. Report of the Chair (For discussion only)

Chair Ballard reported that Board Secretary Roberta Boomer is retiring as of November 2020. He wished her well and welcomed the newly hired Board Secretary, Christine Silva.

He asked Roger Marenco to give a brief check-in on the state of Operations from the Operator perspective.

Roger Marenco, President, TWU Local 250-A stated that the Operators are pushing the agency to bring back rail service and more lines.

#### PUBLIC COMMENT:

Edward Mason recommended that the CAC look at the November 3<sup>rd</sup> Board meeting presentation on the subway. Things are grim as far as the subway reopening. Its still a mystery as to what went wrong technically. There seems to be no project manager to oversee the subway that has been operating for 40 years. To get a perspective on what is going on, he recommends that everyone look at the subway slide presentation.

### 6. Public Comment:

Edward Mason stated that the 511 NextBus feature for the inbound J Church line is working, but the outbound is not working. It's good that Muni implemented 511 for the J Church bus. After seeing Tuesday's report regarding the subway reopening, it made this even more important that it was implemented for the long term.

PUBLIC COMMENT:

Roger Marenco stated that the SFMTA is a conglomerate. The CAC should intervene in everything under the jurisdiction of the conglomerate that is the SFMTA. All of this pertains to transportation and the SFMTA in every way. He urged the CAC to be involved in these types of issues. He stated that TWU Local 250-A supports BAAAG. He asked what the classifications are of the people who are being disciplined the most.

Edward Mason asked if there is a better breakdown of the specifics of the disciplinary action areas were. He also asked for the specific divisions and managers. He would like to see it broken down to a more defined level. It's a reflection on the manager not having employees understand what the requirements are for the position of the job. There needs to be more data to pinpoint where the root problems are.
