2020 State Legislative Session

Transit Related COVID-19 Relief

- Flexibility in State funding sources, but no new funding for transit
- Passage of Senate Bill 288 (Wiener) which will provide California Environmental Quality Act (CEQA) statutory exemptions for key components of our Transportation Recovery Plan, including new temporary transit-only lanes and new bicycle and pedestrian infrastructure



2020 Federal Legislative Session

Transit Related COVID-19 Relief

- Flexibility in uses of federal funding sources
- SFMTA received \$373M in federal funding from the Coronavirus Aid,
 Relief, and Economic Security (CARES) Act to support Muni operations
- Continued advocacy for \$32B for transit in advance of another potential federal funding emergency relief package



COVID-19 Relief

- Advocate for additional emergency funding and statutory changes to provide financial and regulatory relief to address the adverse impact of COVID-19 on the Agency.
- Advance policies set forth in Metropolitan Transportation Commission (MTC)'s Blue Ribbon Transit Recovery Task Force




Transportation Funding

Vision Zero


- Local control of speed-limit setting
