

The proposed terminal location for the 58 Lake Merced is on Buckingham Way, between 19th Avenue and the Stonestown parking lot entrance/exit. Additional terminal space is needed as the 18 46th Avenue, 57 Parkmerced, and SamTrans, uses the curb space along 19th Avenue north of Buckingham Way.												
58 Lake Merced picks up the John Muir Drive portion of the 57 Parkmerced and Sloat section of the 23 Monterey, connecting to BART, Stonestown, and Lakeshore. The route will also connect to John Daly Boulevard and Top of the Hill in Daly City.												
The route is anticipated to begin in August 2021.


