

SAN FRANCISCO MUNICIPAL TRANSPORTATION AGENCY Order # 5247 FOR PUBLIC HEARING

The Sustainable Streets Division of the San Francisco Municipal Transportation Agency will hold a public hearing on Friday, April 4, 2014, at 10:00 AM, in Room 416 (Hearing Room 4), City Hall, 1 Dr. Carlton B. Goodlett Place, San Francisco, CA 94102, to consider the following proposals:

1(a). ESTABLISH – BUS ZONE

26th Street, north side, from Noe Street to 50 feet westerly (removes 1 parking space)

1(b). ESTABLISH – RED ZONE

26th Street, south side, from Castro Street to 20 feet easterly (removes 1 parking space) *

2. <u>ESTABLISH – TOW-AWAY, NO STOPPING ANYTIME</u>

Newhall Street, west side, from 20 feet north of Newcomb Avenue to 40 feet south of Newcomb Avenue (removes 2 parking spaces)

3. ESTABLISH – STOP SIGNS

Cole Street, at Carmel Street, making this intersection an all-way STOP

4. <u>ESTABLISH – RESIDENTIAL PERMIT PARKING AREA S ELIGIBILITY</u> 3910-3912 24th Street (creates permit parking eligibility for this building; no signage changes)

5(a). <u>RESCIND – YELLOW METER LOADING ZONE, 7 AM TO 1 PM, MONDAY THROUGH</u> <u>SATURDAY</u> ESTABLISH – RED ZONE

California Street, south side, from 3 feet to 45 feet west of Hyde Street (meter #1401 and #1403)

5(b). <u>RESCIND – YELLOW METER LOADING ZONE, 7 AM TO 1PM, MONDAY THROUGH</u> <u>SATURDAY</u>

ESTABLISH – GREEN METER, 30-MINUTE TIME LIMIT, 7 AM TO 6 PM

California Street, south side, from 45 feet to 89 feet west of Hyde Street (meter #1405 and #1407) *

6. <u>ESTABLISH – RESIDENTIAL PERMIT PARKING AREA N, 2-HOUR TIME LIMIT,</u> <u>9 AM TO 6 PM, MONDAY THROUGH FRIDAY</u>

Anza Street, both sides, between 11th Avenue and 12th Avenue (2000 Block) 11th Avenue, both sides, between Anza Street and Balboa Street (500 Block)

7. <u>ESTABLISH – RESIDENTIAL PERMIT PARKING AREA W, 2-HOUR TIME LIMIT,</u> <u>8 AM TO 6 PM, MONDAY THROUGH FRIDAY</u>

23rd Street, both sides, between Hampshire Street and Potrero Avenue (2700 Block)

8. <u>RESCIND – RESIDENTIAL PERMIT PARKING AREA V, 2-HOUR TIME LIMIT,</u> <u>8 AM TO 6 PM, MONDAY THROUGH FRIDAY</u>

Faxon Avenue, both sides, between Elmwood Way and Wildwood Way (700 Block)

9. <u>ESTABLISH – RESIDENTIAL PERMIT PARKING AREA U, 2-HOUR TIME LIMIT,</u> <u>7 AM TO 6 PM, MONDAY THROUGH FRIDAY</u>

Folsom Street, both sides, between 12th Street and 13th Street (1600 Block) (Both sides to be eligible for purchasing parking permits, but permit parking signs will only be installed on the south side of the street)

- A. Verna Street, southbound, at Teresita Boulevard, stopping the stem of this T- intersection
- B. Los Palmos Drive, eastbound, at Teresita Boulevard, stopping the stem of this T-intersection
- C. Foerster Street, eastbound, at Teresita Boulevard, stopping the stem of this T-intersection
- D. Molimo Drive, eastbound, at Teresita Boulevard, stopping the stem of this T-intersection
- E. Rio Court, westbound, at Teresita Boulevard, stopping the stem of this T-intersection
- F. El Sereno Court, westbound, at Teresita Boulevard, stopping the stem of this T-intersection
- G. Arroyo Way, northbound and southbound, at Teresita Boulevard, making this intersection a two-way STOP
- H. Gaviota Way, northbound, at Teresita Boulevard, stopping the stem of this T-intersection.
- I. Isola Way, eastbound, at Teresita Boulevard, stopping the stem of this T-intersection
- J. Juanita Way, eastbound, at Teresita Boulevard, stopping the stem of this T-intersection

12. <u>ESTABLISH – NO RIGHT TURN ON RED</u>

San Jose Avenue, northbound, at Geneva Avenue

13. ESTABLISH – NO PARKING, 7 AM TO 7 PM, EVERYDAY

Mission Street, east side, from Ney Street to 155 feet northerly

"30" Sherman Street, west side, from 35 feet to 197 feet south of Cleveland Street (162-foot zone) *

15(a). ESTABLISH – NO PARKING ANYTIME

Geary Boulevard, north side, from 61 feet to 109 feet east of Jordan Avenue (6-foot wide, 48-foot long bulb, removes yellow parking meter #3416)

15(b). ESTABLISH – YELLOW METER LOADING ZONE, 8 AM TO 6 PM, MONDAY THROUGH SATURDAY, NOON TO 6 PM, SUNDAY

CITY and COUNTY

24th Street, south side, from 55 feet west of Noe Street to 81 feet westerly (this shifts The existing yellow zone to the end of the proposed bus bulb at Noe) *

* Items denoted with an asterisk (*) can be given final approval at the public hearing. Otherwise, the SFMTA Board will make the final approval at a later date based on the outcome at the public hearing.

The purpose of traffic engineering hearings for the San Francisco Municipal Transportation Agency (SFMTA) Sustainable Streets Division is for residents to express their concerns regarding the posted parking and traffic changes affecting their streets. At the hearing, the public hearing officer, after reviewing the items and listening to residents, will make a decision as to whether the items are approved or not. Any interested parties are encouraged to attend.
