This project will address traffic safety concerns using the following cost-effective, reversible treatments that can be easily implemented:

- Removing one westbound travel lane and reconfiguring some parallel parking to perpendicular vehicle parking
- Installing traffic calming devices to encourage driving at safer speeds
- Installing pedestrian safety improvements at intersections to improve visibility
- Upgrading the Williams Avenue at 3rd Street Muni flag stop to a bus zone/shelter and removing the Van Dyke Avenue at Lane Street Muni flag stop to improve stop spacing

Pending project approvals, implementation could begin as early as late Summer or early Fall 2021.

If a City Traffic Engineer disapproves a parking or traffic modification and a member of the public requests SFMTA review of that decision, the additional review shall be conducted pursuant to Division II, Section 203 of the Transportation Code. City Traffic Engineer decisions will be posted on City Traffic Engineer decisions will be posted on SFMTA.com/EngineeringResults by 5 p.m. on the Friday following the public hearing. Final SFMTA Decisions involving certain parking or traffic modifications, whether made by the City Traffic Engineer or the SFMTA Board, can be reviewed by the Board of Supervisors pursuant to [Ordinance 127-18](#).
