FOR PUBLIC HEARING

The Sustainable Streets Division of the San Francisco Municipal Transportation Agency will hold a public hearing on Friday, August 29, 2014 at 10:00 AM, in Room 416 (Hearing Room 4), City Hall, 1 Dr. Carlton B. Goodlett Place, San Francisco, CA 94102, to consider the following proposals:

**ESTABLISH – DUAL-USE ZONE: YELLOW METERED LOADING ZONE, 7AM TO 6PM, MONDAY THROUGH SATURDAY; AND PASSENGER LOADING ZONE, 6PM TO MIDNIGHT, MONDAY THROUGH SATURDAY, 7AM TO MIDNIGHT, SUNDAY**

"2" Fell Street, north side, from 0 feet to 40 feet east of meter stall number 8, at parking meter stalls number 4 and 6. (40-foot zone)

**REVOKE – 6 WHEEL METERED LOADING ZONE 7AM-6PM MONDAY THROUGH FRIDAY**  
**ESTABLISH – DUAL-USE ZONE: 6 WHEEL METERED LOADING ZONE 7AM TO 5PM, MONDAY THROUGH FRIDAY; AND TAXI ZONE 5PM-11PM MONDAY THROUGH FRIDAY**

"40" Fremont Street, west side, from 193 feet to 231 feet south of Market Street, at parking meter stalls number 20 and 22. (38-foot zone)

**ESTABLISH – YELLOW LOADING ZONE, 8AM TO 6PM, MONDAY THROUGH FRIDAY**

"100" Mississippi Street, west side, from 8.5 feet to 30.5 feet south of 17th Street (22-foot zone)

**REVOKE – YELLOW METERED LOADING ZONE 9AM TO 6PM, MONDAY THROUGH FRIDAY**

101 Fell Street, south side, from 20 feet to 44 feet west of Van Ness Avenue, at parking meter stalls number 3. (24-foot zone)

**ESTABLISH – YELLOW METERED LOADING ZONE, 9AM TO 6PM, MONDAY THROUGH SATURDAY**

101 Fell Street, south side, from 20 feet to 66 feet west of Van Ness Avenue, at parking meter stalls number 3 and 5. (46-foot zone)

**ESTABLISH – YELLOW METERED LOADING ZONE, 8 AM TO NOON, MONDAY THROUGH FRIDAY**

212 Utah Street, west side, from 0 feet to 20 feet north of the south property line, at (new) parking meter stalls number 16 and 18. (20-foot zone contingent upon raising of non-functional driveway)

**ESTABLISH – TAXI ZONE, 6PM TO 4AM, DAILY**

"298" Columbus Avenue, east side, from 19 feet to 63 feet south of Broadway, at parking meter stalls number 234 and 236 (44-foot zone)

**REVOKE – RED ZONE**

**ESTABLISH – TAXI ZONE, AT ALL TIMES**

"259" Columbus Avenue, west side, from 97 feet to 130 feet south of Broadway Street (33-foot zone)

**REVOKE – YELLOW LOADING ZONES, 8AM TO 6PM, MONDAY THROUGH SATURDAY**

460 Bryant Street, north side, from 3 feet to 28 feet and from 42 feet to 76 feet west of the east property line, at parking meter stalls number 452 and 456 (59-foot zone)

**ESTABLISH – PART-TIME PASSENGER LOADING ZONE, 8AM TO 6PM, MONDAY THROUGH FRIDAY**

460 Bryant Street, north side, from 5 feet to 36 feet east of fire hydrant. (31-foot zone)

**ESTABLISH – METERED MOTORCYCLE PARKING STALLS, 9AM TO 6PM, MONDAY THROUGH SATURDAY**

460 Bryant Street, north side, from 5 feet to 57.5 feet west of the fire hydrant (15 new spaces, 3.5 feet each) replacing parking meter stalls number 468 and 470.

**REVOKE – 6 WHEEL METERED LOADING ZONE, 7AM TO 6PM, MONDAY THROUGH FRIDAY.**

625 – 639 Bush Street, south side, from 9 feet to 71 feet east of Chelsea Place at meters stalls number 621, 619 and 617. (62-foot zone)

**ESTABLISH – GREEN ZONE.**

1926 Lombard Street, north side, from 0 feet to 18 feet east of the west property line. (18-foot zone)

**REVOKE – PART TIME PASSENGER LOADING ZONE, 8AM TO 6PM, MONDAY THROUGH FRIDAY**

“2298” Powell Street, east side, from 0 feet to 22 feet south of Bay Street. (22-foot zone)

**REVOKE 6 WHEEL TRUCK LOADING ZONE, 8AM TO 6PM, MONDAY THROUGH FRIDAY**

“2298” Powell Street east side from 22 feet to 44 feet south of Bay Street. (22-foot zone)

**ESTABLISH – GREEN ZONE 9AM TO 6PM MONDAY THROUGH SATURDAY**

2598 Folsom Street, west side, from 10 feet to 28 feet north of 22<sup>nd</sup> Street. (18-foot zone)

**REVOKE GREEN ZONE**

3101 Octavia Street, west side, from 0 feet to 22 feet north of Lombard Street. (22-foot zone)

**ESTABLISH – GREEN ZONE 9AM TO 6PM MONDAY THROUGH SATURDAY**

3301 Cesar Chavez St, south side from 10.5 feet to 28.5 feet west of the South Van Ness Avenue westerly crosswalk. (18-foot zone)

**ESTABLISH – PART-TIME PASSENGER LOADING ZONE, 5PM TO 10PM, DAILY**

3318 Fillmore St, east side, from 0 feet to 40 feet north of meter stall number 3308, at meter stalls 3310 and 3312. (40-foot zone)

Public hearings are held once a month at City Hall to legislate the installation of new colored zones. The zones usually recommended for this process are blue, green, white, and yellow. The purpose of the hearing is for residents to express their concerns regarding proposed changes affecting their streets. All interested parties are encouraged to attend. At the Public Hearing, the Hearing Officer will review the items and listen to residents, then make a final decision. Upon approval and payment of any applicable installation fees, zones will be installed as soon as scheduling permits.
