Over the years, certain transit only lanes were modified without proper approvals. This legislation package codifies those lanes and provides background on how they came to be.




Figure 1: Overview map showing the 3 transit only lane locations.




Figure 4: Image from July 2015, on Powell Street, looking southbound towards California Street. Image courtesy of Google Maps





Figure 5: Image from June 2021, on Powell Street, looking southbound towards




Figure 6: April 2016 image showing the roadway under construction, before the two-way street conversion. Image courtesy of Google Maps.





Figure 7: February 2017, showing the 2-way street conversion and the southbound truck, taxi, and bus only lane. Image courtesy of Google Maps.

FILE NAME: DATE: --/-- **Judah Street:** The center track lanes have always had some kind of transit only lane, dating back from the early 1950's. Initially the signage on the corridor was consistent west of 18<sup>th</sup> Avenue, with left turning vehicles and trains only. For the section between 20<sup>th</sup> and 19<sup>th</sup> avenues, the lanes were colored red and both directions were changed to modify the transit only lane (each direction has different regulations).




Figure 10: Judah Street, looking westbound at 19<sup>th</sup> Avenue, in May 2016, showing the red lane and BUS & TAXI pavement markings. Image courtesy of Google Maps.




Figure 13: Judah Street, looking eastbound at 20<sup>th</sup> Avenue, in May 2016, showing the red lane and MUNI ONLY pavement markings. Image courtesy of Google Maps.







Figure 14: Judah Street, looking eastbound at 20th Avenue, in May 2021. Image courtesy of Google Maps.
