6. Introduction of New or Unfinished Business by Board Members

Director Lai announced her resignation from the Board and expressed appreciation to the SFMTA, fellow board members, and the community.

Director Eaken thanked Director Lai for her time on the Board and shared that she would be taking a break, returning in September.

Directors Heminger, Cajina, Hinze, and Chair Borden thanked Director Lai for her service.

PUBLIC COMMENT:

Aleta Dupree reminded the Board to not forget about regionality and wished Director Lai well.

David Pilpel thanked Director Lai for her service and appreciated her comments about being able to have respectful disagreements.

Francisco DeCosta shared that good leaders know the way, show the way, and go the way, and also expressed support for a SFMTA needs assessment.

Richard Rothman commented on public engagement and hoped to see the SFMTA expand and succeed.

Acting Director of Transportation Tom Maguire provided updates on the election and Proposition A, Vision Zero fatalities, the recent Central Subway electrical fire, scooter share permit extension, Warriors parade, Pride weekend support, SamTrans Bus Rodeo, and 4th of July Muni service.

Director Lai requested an update on which projects would be impacted given the election results.



Directors Hinze, Heminger, and Eaken requested an update on Vision Zero and the future of Slow Streets.

PUBLIC COMMENT:

Zack Lipton expressed support for a permanent Slow Lake Street and concern for the proposed street design.

Nancy Meleane expressed support for a permanent Slow Lake Street and concern for the proposed design barriers.

Richard Rothman commented on Prop A, sharing that people were instead interested in the closing of Great Highway and JFK Drive.

Aleta Dupree hoped that the SFMTA could find various alternative means to fund rebuilding Muni and looked forward to the scooter program extension.

Herbert Weiner shared that the SFMTA lost credibility with the public and urged the SFMTA to start listening.

Michael Shizner thanked staff for restoring the J Church line to the tunnel and proposed converting one or two S Shuttle runs to improve headways.

Steve Macijamie expressed concern over the Warriors parade and shared concern about signage and reroutes.

Molly Hedin expressed support for Slow Lake Street and concern for the temporary barriers.

Martin Munoz expressed concern over the Lake Street barrier design and asked the Board to redesign with barriers on every street.

Reed expressed concern of the Lake Street design and urged the SFMTA to go further.

Jason Bready expressed support for a slower Lake Street and was discouraged by the design.

Speaker expressed concern over the parade reroutes, missing signage and hoped that the SFMTA learned from this experience.

David Pilpel shared that any action on Slow Streets would displease both sides further reducing trust in the SFMTA and expressed concern over federal operating funds drying up.



Dave Alexander expressed concern for Lake Street and thanked Director Heminger for his comments on Lake Street.

Stacy Randecker shared that we should be funding transit over all other modes of transportation and reminded the SFMTA that Vision Zero has 18 months to reach it.

David Hampshire expressed support for Slow Lake Street and concern over the rules and temporary signage currently in place.

Alex Barr expressed support for Slow Lake Street and urged the SFMTA for barriers.

Zach Anderson shared about using Slow Lake Street six to seven times a week and expressed concern over diverters.

Calvin Thigpen expressed concern over the latest design for Lake Street and urged the SFMTA to install as many barriers and diverters as possible.

Edward Mason expressed frustration while riding transit during the Warriors parade.

Speaker expressed concern over the Lake Street barrier design and requested traffic diverters be added at every intersection.

Speaker thanked the Board for approving Lake Street.

Speaker expressed concern about Lake Street signage, barriers, and diverters.

Luke Bornheimer thanked staff for their work on Lake Street expressed concern over the proposed design.

Code Chapter 31: For identified Approval Actions, the Planning Department or the SFMTA has issued a CEQA exemption determination or negative declaration, which may be viewed online at the Planning Department's website. Following approval of the item by the SFMTA Board, the CEQA determination is subject to appeal within the time frame specified in S.F. Administrative Code Section 31.16 which is typically within 30 calendar days. For information on filing a CEQA appeal, contact the Clerk of the Board of Supervisors at City Hall, 1 Dr. Carlton B. Goodlett Place, Room 244, San Francisco, CA 94102, or call 415.554.5184. Under CEQA, in a later court challenge, a litigant may be limited to raising only those issues previously raised at a hearing on the project or submitted in writing to the City prior to or at such hearing, or as part of the appeal hearing process on the CEQA decision.
