#### **PUBLIC COMMENT:**

Edward Mason asked if the agency expects any patrons to board at Geneva and San Jose, with all the new housing at that location. He asked if there will be any parking impact from that housing area or is everyone that ends up residing in that upper yard housing going to be expected not to have an automobile and rely on transit.

Hesham asked if the tracks on San Jose Ave will be replaced or painted over. He also asked how much travel-time savings the project will create.

8. Presentation, discussion, and possible action regarding extended parking meter hours. (Hank Willson, Policy Manager, Parking & Curb Management. Explanatory documents include a slide presentation.)

Kenya Wheeler, Principal Transportation Planner, Curb Management, presented the item.



PUBLIC COMMENT:

Edward Mason stated that there is a lack of enforcement. He suggested assessing medallion costs on each one of the commuter buses for additional revenue.

Hesham stated that the plan needs to be ironed out a little more.

Richard Becker stated that this is a terrible proposal. This is the most unpopular proposal in his 40+ years of being a community activist. He said the SFMTA is trying to squeeze every last penny out of poor people and working-class people even though the City has more billionaires per capita than any other city in the United States.

Scott Brown stated that this is an obscene attack on the working class. The City refuses to tax big business. It's totally disconnected from reality.

Stephanie stated that this is low hanging fruit. It's awful what the SFMTA is doing to push people into a desperate situation.

Gloria stated that she is a delegate to the SF Labor Council. She stated that several unions are against this proposal. New condos going up in the Mission don't require parking spaces anymore like they used to. The SFMTA is squeezing everybody into the street and charging far higher prices. It's a neighborhood of poor people and this is not going to fly.

Ramsey stated that this is a very unpopular proposal. He stated that the fiscal crisis shouldn't be taken out on the poor. This is unfair to the working class.

Sanika Mahajan stated that it's crazy for the agency to pass extended parking meter hours off as a measure to reduce emissions, to reduce traffic, and to raise revenue, when there are so many alternative ways to do that. Cruise cars are littering the streets of San Francisco. with plans for them to release even more. And yet, the SFMTA is not taxing Cruise anymore for their use of the public streets. They're not taxing Google or Facebook more for their use of public bus stops for their shuttles.

Paula Katz stated that she strongly opposes the extension to the parking meters. The people who are going to be hurt are the merchants.

Prianna Nunn stated that she works for a tech company that is not paying taxes and should be. She opposes the proposal to extend parking meters. It shouldn't be on the working class.
