#### ORDER OF BUSINESS

#### 1. Call to Order

Chairman Nolan called the meeting to order at 1:00 p.m.

3. Announcement of prohibition of sound producing devices during the meeting.

Chairman Nolan announced that the ringing of and use of cell phones, pagers and similar sound-producing electronic devices are prohibited at the meeting. He advised that any person responsible for the ringing or use of a cell phone, pager, or other similar sound-producing electronic devices might be removed from the meeting. He also advised that cell phones that are set on "vibrate" cause microphone interference and requested that they be placed in the "off" position.

Board Secretary Boomer announced that with respect to Item 10.1 J, the proposal to establish a tow-away zone on Mission at 24th had been removed from the agenda at the request of staff. Item 10.1 J is only for the tow-away proposal on Mission at 16th Street.

Director Lee noted an issue with a no parking sign on the 800 block of Kearny that is a problem for the community. He requested that staff look into it.

Kathy Broussard, Transit Fare Inspector - Supervisor/Investigator, also recognized Ms. Militello.

Director Reiskin discussed a program to incentivize taxi drivers to pick up people in wheelchairs and the status of the Central Subway project.

Director Heinicke noted a previous request regarding the plan for Market Street. Director Reiskin stated that he would present options in January.

#### 9. Public Comment

Vera Haile discussed the accessible parking recommendations for disabled parking and the charging of fees. There are 60,000 people in SF with disable placards. Most seniors who have them live on fixed incomes and the added expense will be a great hardship on them. It will be hard to visit friends, get to appointments or volunteer. Changing the meter rate will not bring more income.

- L. ESTABLISH NO PARKING 9 AM TO 4 PM DAILY; TOW-AWAY, 4 PM TO 6 PM, MONDAY THROUGH FRIDAY Pacific Avenue, north side, from Stockton Street to 63 feet easterly.
- M. RESCIND TOW-AWAY NO STOPPING, 4 PM TO 6 PM EVERYDAY; 8 AM TO 6 PM, SATURDAY, SUNDAY AND HOLIDAYS; NO PARKING ALL OTHER TIMES Pacific Avenue, north side, from Stockton Street to 80 feet westerly.
- N. ESTABLISH BUS ZONE Pacific Avenue, north side, from Stockton Street to 80 feet westerly.
