#### ORDER OF BUSINESS

## 1. Call to Order

Chairman Nolan called the meeting to order at 1:03 p.m.

# 2. Roll Call

3. Announcement of prohibition of sound producing devices during the meeting.

Chairman Nolan announced that the ringing of and use of cell phones, pagers and similar sound-producing electronic devices are prohibited at the meeting. He advised that any person responsible for the ringing or use of a cell phone, pager, or other similar sound-producing electronic devices might be removed from the meeting. He also advised that cell phones that are set on "vibrate" cause microphone interference and requested that they be placed in the "off" position.

# 4. Approval of Minutes

Director Reiskin presented a trophy to the Materials Management Storerooms, and Storekeepers section for receiving the fourth quarter Maintenance Safety Award. Bond Yee, Director, Sustainable Streets recognized Maria Contreras, Parking Control Officer and Donald Ellison, Director, Human Resources recognized Redeena Cleaver, Training Instructor.

Director Reiskin discussed the Combined Charities Campaign, a tentative agreement with shuttle providers and a recent bike count.

#### 9. Public Comment

Emil Lawrence stated that there were a lot of items on 10.2 but nothing about taxis. Taxis can't park anywhere in the city. He has seen a lot of awards going to DPT/Muni employees but there was no award for the woman who lost her child due to an Uber taxi. These vehicles should be under the mandate of the city.

Mark Gruberg stated that the incident is shocking but isn't surprising that Uber is denying responsibility for the accident that killed a six -year old girl. This is consistent with Uber's position that it's a software company and isn't subject to any regulation. The CPUC has said differently. It is the height of regulatory irresponsibility to leave the public unprotected. The driver's personal insurance will almost certainly deny coverage. They have tried time after time to impress on the CPUC that there are gaps in insurance rules.

Herbert Weiner discussed documentation that there is increased difficulty as one ages with walking and climbing. The TEP has provided no evidence that walking long distances by the elderly will be detrimental to their health. These hardships begin at age 65.

Mary McGuire stated that the MTA is responsible for the death of the young girl. Drivers have come to the Board time and time again that TNC cars aren't insured and that Uber will deny responsibility. Uber isn't covering third party victims. Their business model requires drivers to text while driving but that's illegal. The SFMTA advertises these services and so it is responsible.

Carl Macmurdo urged the Board to not put a medallion lease fee cap on the agenda. It will put a wedge between drivers and color schemes. Color schemes that cut corners have more money to offer drivers. He expressed support for the plan to set standards. With regard to the accident at Ellis and Polk streets, Uber is perpetrating insurance fraud. TNC drivers should have to have proof of insurance before an accident occurs.
