6. Introduction of New or Unfinished Business by Board Members

Chair Eaken expressed concern about bike network signage, particularly at the end of the JFK Promenade.



Chair Eaken returned to Item 6 after Item 12 and provided a report back from the last Vision Zero Committee Meeting on June 11, 2024.

Director Hinze shared about the Vision Zero Committee Meeting and that the next meeting would be at the end of August.

Tarlov shared that she listened to the meeting and commented on the police department presentation and enforcement.

PUBLIC COMMENT:

Speaker shared that Slow Streets signage does not include skateboards and continue to be left out.

Mark Soloman expressed concern about Vision Zero, inquired about high injury rates, and the police department.

Joe Schurillo expressed concern about Dolores Hill Bomb safety, sharing that every day we must work to make streets safer.

Aaron Breetwor expressed concern about outreach regarding the Active Communities Plan and Biking and Rolling Plan.

 - A. RESCIND TOW-AWAY NO STOPPING ANYTIME, 19th Avenue, east side, from 148 feet to 477 feet north of Holloway Avenue.

Authorizing the Director of Transportation to execute Contract No. SFMTA-2023-24 with Nomad Transit, LLC to develop, launch, market, operate, manage, and maintain a turnkey community based on-demand shuttle service for the Bayview-Hunters Point neighborhood as part of the "Our Community, Our Shuttle: Bayview-Hunters Point Equitable Mobility" Program for a total amount not to exceed \$4,341,992 and an initial term expiring March 15, 2026, with two one-year options to extend for up to an additional two years. (Explanatory documents include a staff report and resolutions.)

Mark Solomon urged the agency to ensure enforcement components so there are consequences to motorists not following the law.

Chair Eaken reopened Item 6 to share about a recent Vision Zero Committee Meeting.

Chair Eaken recessed the meeting at 2:41pm and reconvened the meeting at 3:00pm.

Receiving an update on the Valencia Bikeway Project, also known as the Mid-Valencia Bikeway Pilot, which seeks to improve safety, preserve economic vitality, and ensure movement and access of goods and people on Valencia Street between 15th and 23rd streets, and endorsing, but not approving, a shift in the current design from a center-running to a side-running bikeway. (Explanatory documents include a staff report and resolution.)

their needs for quantity and available hours related to parking and loading for commercial deliveries and continue to make adjustments to existing parking and loading spaces to align limited supply with those needs whenever possible; and be it further"; (3) "RESOLVED, That the San Francisco Municipal Transportation Agency Board of Directors directs staff to work closely with the Valencia corridor business community and other key stakeholders to accomplish any eventual construction at a time and in a manner that will minimize, to the fullest extent practicable, disruptions to the largest number of businesses possible" and approve as amended:

California Environmental Quality Act (CEQA) Appeal Rights under S.F. Admin. Code Chapter 31: For identified Approval Actions, the Planning Department or the SFMTA has issued a CEQA exemption determination or negative declaration, which may be viewed online at the Planning Department's website. Following approval of the item by the SFMTA Board, the CEQA determination is subject to appeal within the time frame specified in S.F. Administrative Code Section 31.16 which is typically within 30 calendar days. For information on filing a CEQA appeal, contact the Clerk of the Board of Supervisors at City Hall, 1 Dr. Carlton B. Goodlett Place, Room 244, San Francisco, CA 94102, or call 415.554.5184. Under CEQA, in a later court challenge, a litigant may be limited to raising only those issues previously raised at a hearing on the project or submitted in writing to the City prior to or at such hearing, or as part of the appeal hearing process on the CEQA decision.

<u>Board of Supervisors review of certain SFMTA Decisions:</u> Certain parking and traffic modifications as well as Private Transportation Programs that involve certain parking modifications can be reviewed by the Board of Supervisors. These decisions are subject to review within 30 calendar days after they are made by the SFMTA Board of Directors.
