Director Tumlin introduced Julie Kirschbaum, Director of Transit, to recognize Denise Green, and the Transit Safety Implementation Team. Director Tumlin shared about the L Taraval Project, Accessibility Needs Assessment Survey, Valencia open houses, Muni Heritage Weekend, and various upcoming events.

Thierry expressed concern about violating rules and changing costs.

8. New or Unfinished Business by Board Members

Director Hinze and Director Heminger shared about the first Muni Funding Working Group meeting.

Director Tumlin appreciated the Controller's Office for organizing the meetings and materials on the website, <u>https://www.sf.gov/muni-funding-working-group</u>.

PUBLIC COMMENT:

Thierry commented on problem solving and miseducation.

9. Public Comment

Members of the public may address the SFMTA Board of Directors on matters that are within the Board's jurisdiction and are not on today's calendar.

Thierry shared about miseducation, that the whole system is wrong.

Christin Evans expressed disappointment with event on Zoo Road in August and lack of collaboration among departments and asked that the departments work together.



Sasha Perigo expressed concern about a proposed citywide ban on overnight parking, sharing that there needs to be more solutions for people without homes.

Shiba Bandeeba expressed concern about towing and targeting people and communities with the most financial vulnerability, urging the Board vote against the ban.

Alejandra Rubio urged Board to vote against a ban on overnight parking and asked for safe parking sites.

Eleana Binder expressed concern about a ban that targets Recreational Vehicles (RVs), urging the SFMTA to partner with the Department of Homelessness and Supportive Housing (HSH).

Le Buse expressed concerned about a ban on overnight parking, urging the Board to protect hard working family and work on compassionate solutions.

Hans Ege Wenger urged the Board to not pass a citywide ban and instead push for safe parking sites and affordable housing for all.

Yolanda Catzalo expressed concern about displacement on Winston Drive and asked that the agency help.

Karina Grifter shared about an experience riding a cable car with a person experiencing homelessness.

Jennifer Friedenbach expressed concern about scapegoating immigrants and stability for homeless children.

Ocean Coast expressed concern for those unhoused with a disability and shared about his homelessness experience.

Alisha Zhao urged the Board to not pass citywide ban on overnight vehicles, sharing that it will harm families and lead to deeper instability.

Candy Smallwood urged the Board to not pass the policy, sharing that it will cause harm.

Melodie shared about her experience living in an RV while seeking services and urged the Board not to pass a ban.

Virginia Taylor urged the Board to not pass a citywide ban and shared about long term and health issues related to homelessness for families.



Flo Kelly shared comments from a March 3, 2020 public hearing.

Armando Martinez urged the Board to not pass a ban, sharing that it does not make sense for a city that is known for its compassion.

Jose expressed concern about rent increases, homelessness and towing.

Lukas Illa expressed concern about safe parking sites and questioned whose voices are being prioritized.

Malena Cabada shared about a recent Vision Zero letter and requested the Board enact the recommendations.

Selene Smith expressed concern about housing affordability and questioned why people cannot live in RVs if its their choice.

Marita Villagomez expressed concern about a citywide ban, sharing that safe parking sites must be prioritized.

Walter Mejia shared about living in a RV on Winston Drive, Zoo Road and Lake Merced, requesting that a safe space is needed.

Silverio Zepeda shared about living in a RV and being a good neighbor, expressing the need for a safe location to park.

Evie thanked the Board in advance for not passing a ban on oversized vehicles providing shelter, sharing that we can do better.

Lucas urged the Board to not pass a ban, sharing that they are trying to survive in San Francisco and need a place to live.

Gabriel Medina urged the Board for more safe parking sites and shared about an increase in Latino homelessness.

Elieselle shared about living in a RV and urged the Board to vote against a ban.

Herbert Weiner shared that there should be a ban on towing and that more bus service should be a priority.

For these parking and traffic modifications that received a categorical exemption, the proposed SFMTA Board action constitutes the Approval Action as defined by Chapter 31 of the San Francisco Administrative Code.  - E. ESTABLISH RED ZONE Plum Street, north side, from Mission Street to 20 feet easterly.
 - F. RESCIND 6-WHEEL TRUCK LOADING ZONE, 7 AM TO 6 PM, MONDAY THROUGH FRIDAY – Plum Street, north side, from 67 feet to 108 feet east of Mission Street.
 - G. ESTABLISH TOW-AWAY NO STOPPING ANY TIME 11th Street, east side, from Folsom Street to 27 feet northerly 11th Street, east side, from Folsom Street to 49 feet southerly.

10.2. Approving Contract No. SFMTA-2024-52-LOC with Claremont Behavioral Services, Inc., to provide the Employee Assistance Program, Peer Assistance Program, Critical Incidents Program, As-needed Substance Abuse Professional Services, As-needed Conflict Resolution Training, and related professional services (collectively, Employee Assistance Services) for a base term of 5 years with a not to exceed amount of \$1,926,445 and two options to extend the term by two, two-years periods for \$793,696 and \$817,504 respectively for an total not to exceed amount over 9 years not to exceed \$3,537,645. (Explanatory documents include a staff report and resolution.)

10.3. Authorizing the Director of Transportation to execute Contract Modification No. 1 (Final) to Contract No. 1296R, Muni Metro System Automatic Train Control System (ATCS) Subway Wiring Replacement Van Ness, with Phoenix Electric Company, to extend the contract term; adjust the quantity in the Schedule of Bid Prices to reflect the actual quantity of work performed and to close out the contract. This Modification decreases the Contract Amount by \$59,970.77, for a total Contract Amount of \$1,824,029.23 and increase the overall Contract Time to substantial completion by 372 days for a total Contract Time of 647 days to Substantial Completion. Amending the Transportation Code, Division II, Section 702 to reduce the speed limit on safety corridors from 35 miles per hour to 30 miles per hour on four street segments: Alemany Boulevard between Junipero Serra Boulevard and Mission Street overpass, Bayshore Boulevard between Hester Avenue (north intersection) and the County Line, Geneva Avenue between Moscow Street and the County Line, and Sloat Boulevard between 39th Avenue and Great Highway; reduce the speed limit from 30 miles per hour to 25 miles per hour on two street segments: Fulton Street between Arguello Boulevard and the Great Highway, and San Jose Avenue between Randall and Guerrero Streets; and reduce the speed limit from 25 miles per hour to 20 miles per hour on Mission Street between 3rd Street and 12th Street. Code Chapter 31: For identified Approval Actions, the Planning Department or the SFMTA has issued a CEQA exemption determination or negative declaration, which may be viewed online at the Planning Department's website. Following approval of the item by the SFMTA Board, the CEQA determination is subject to appeal within the time frame specified in S.F. Administrative Code Section 31.16 which is typically within 30 calendar days. For information on filing a CEQA appeal, contact the Clerk of the Board of Supervisors at City Hall, 1 Dr. Carlton B. Goodlett Place, Room 244, San Francisco, CA 94102, or call 415.554.5184. Under CEQA, in a later court challenge, a litigant may be limited to raising only those issues previously raised at a hearing on the project or submitted in writing to the City prior to or at such hearing, or as part of the appeal hearing process on the CEQA decision.

<u>Board of Supervisors review of certain SFMTA Decisions:</u> Certain parking and traffic modifications as well as Private Transportation Programs that involve certain parking modifications can be reviewed by the Board of Supervisors. These decisions are subject to review within 30 calendar days after they are made by the SFMTA Board of Directors.
